Committee member Albin-Smith suggested to hire consultant for feasibility study, mapping, and cost for policy implementation. Also consider; purchasing micro-trenching equipment for lower impact digging, fiber optics and all dry lined utilities.

Chair Peters recommended to look into City of Winters' policy and consider their feedback. Committee agreed to take item to council to discuss total costs.

3C. 22-178 Public Works Director Oral Report on Departmental Updates and Items of Interest

Director Smith provided update on current and forthcoming Public Works projects and current rain conditions delaying the anticipated drought.
