Mayor Lee called the meeting to order at 6:00 PM, all Councilmembers appearing via video conference.

Mayor Lee extended the term of two ad hoc committees. Both the Broadband Ad Hoc Committee and the Council Goal #2 Ad Hoc Committee (Partner with Educational Institutions) are extended for another six months, through February 10, 2021.

#### 3. STAFF COMMENTS

City Manager Miller provided a financial update and noted that the City received the Government Finance Officers Association's excellence award for the Comprehensive Annual Financial Report for year ending June 30, 2019. Miller announced that the Kid Food Box program will continue to operate at the Food Bank. Thirty-five Tenant Based Rental

Assistance applications were received today; the City will distribute application forms again on Wednesday between 3 and 5 PM. The City Manager also commented on Waste Management bulk pickup, Coastal Cleanup Day, and Mendo Recycle's cleanup of the City's corporation yard. City Clerk Lemos gave an election update and announced a special meeting set for August 13 for Council to decide whether to appoint the two incumbents to the two open Council seats.

#### 4. MATTERS FROM COUNCILMEMBERS

Vice Mayor Norvell suggested that the Council issue a new letter regarding the Microgrid project in the city, stating the Council is neutral on the project. The project has changed since the Council's letter of support dated January 15, 2020 and PG&E is no longer supporting the project. Council directed the City Manager to draft a letter for the next Consent Calendar. Councilmember Albin-Smith reported on recent Mendocino Transit Authority (MTA) meetings and changes to MTA staff. Mayor Lee reported that he hosted two video forums last week on COVID-19 featuring the hospital's chief of staff Dr. William Miller and City Manager Tabatha Miller.
