**RESOLUTION OF THE FORT BRAGG CITY COUNCIL  
ACCEPTING THE BID OF WESCO SERVICES LLC DBA SLS ENERGY  
SERVICES AS THE LOWEST RESPONSIVE BID, AWARDING THE CV  
STARR LED LIGHTING PROJECT (PROJECT), CITY PROJECT NO. PWP-  
00114, TO WESCO SERVICES LLC DBA SLS ENERGY SERVICES AND  
AUTHORIZING CITY MANAGER TO EXECUTE CONTRACT (AMOUNT NOT  
TO EXCEED \$106,562.72), AMENDING THE 2019-2020 BUDGET  
(AMENDMENT NO. 2020-04)**

**WHEREAS**, in accordance with California Public Contract Code 20164 and other applicable laws, the CV Starr LED Lighting Project, City Project No. PWP-00114 (“Project”) was advertised for bid on August 22, 2019 and August 29, 2019; and

**WHEREAS**, CV Starr staff has pursued energy saving projects to reduce costs at the facility; and

**WHEREAS**, PG&E provides zero interest loans for the purpose of lighting upgrades to reduce energy usage for public agencies; and

**WHEREAS**, loan payments will be added to PG&E account invoices and are anticipated to be cost neutral; and

**WHEREAS**, the City received (3) bids for this Project; Gel America, Inc., Fort Bragg Electric and WESCO **Services** LLC.

**WHEREAS**, staff reviewed the bids and found that Gel America did not provide a responsive bid; and

**WHEREAS**, WESCO Services LLC. was found to have provided the lowest responsive and responsible bid; and

**WHEREAS**, based on all the evidence presented, the City Council finds as follows:

1. This project is a positive step in the reduction of greenhouse gas.
2. The bid of WESCO Services LLC. meets the requirement of the Project bid documents and is considered responsive.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Fort Bragg does hereby approve a Project Agreement with WESCO Services LLC. for the CV Starr LED Lighting Project and authorizes the City Manager to execute the same upon execution by Contractor (Amount Not to Exceed \$106,562.72).
