Director John Smith provided updates on significant projects such as:

- Biosolids Dryer
- Bainbridge Park Playground Upgrade/Funding
- Bainbridge Park Soccer Fields/Notice Inviting Bid
- Fire Station Rehab
- Town Hall Improvement

- Streets Rehab Project
- School Zone Traffic Signs
- Water Distribution Project Rehab/Funding
- North Water Sewer Extension
- Water Meter Replacement Project
- WWTP Discharge Generator Project

Committee member Peters asked Director Smith to follow up with member of the public Kathy Silva regarding Bainbridge Parks' maintenance. Director Smith provided additional updates on playground rehab funding and maintenance staff shortage and current rain that is causing park maintenance set backs.

Committee member Albin-Smith questioned the possibility of establishing a vegetation/weed abatement program or group. Director Smith mentioned intentions and plans to eventually establish a parks department for maintenance focus and priorities, and reported progress in other maintenance areas such as water/sewer and Coastal Trail priorities.

4. MATTERS FROM COMMITTEE / STAFF

City Manager David Spaur requested to program a special meeting to discuss the deferral of fees or fee waiver for businesses within the Central Business District. Both committee members agreed to a special meeting to be scheduled before June 27.

Director Smith provided an update on new garbage pick up providers, Redwood Waste Solutions. Transition is on schedule, new cans to be delivered as planned for residential and commercial accounts.

Safety and dangers of electric bikes/devices on Coastal Trail was discussed. Installing speed limit signs and municipal codes to enforce motorized motors recommended. Director Smith responded electric motors on the trail are prohibited and enforceable with the exception of motorized wheel chairs. PD Chief notified and will attempt to provide additional watch on the trail. Committee member Peters requested continuing this item on the next meeting.

Chair Peters requested a status on the "No Vending" signs at Bainbridge Park. No status on sign delivery was available.

Committee member Albin-Smith reported she prepared a draft "Tree Protection Ordinance". Also requested a status on the well to be dug at CV Starr Centers' premises. Director Smith reported to committee members this would be a final coarse of action, a back-up for additional water resources.

Does PG&E have generators in FB for outages? I don't see any.

3B. this is just about as misguided a plan as I can imagine. This was attempted in the 2004 general plan and squashed then. This would be just one more no growth aspect of our code now. Which is terrible at best in my opinion, having worked with it since created. One more obstacle, time and money to have a person remove a tree, subject to who knows who's opinion. I think the concept of private property rights have been totally misplaced. This is still a timber and fishing community, or it is when you want to restrict development to "reflect" the same. The city has a no growth message to developers, this will make it worse, if that is possible.

I own a few properties in town, I will survey them and if there are any trees that I feel should go away, for whatever reason, dead, dying, then they will be gone shortly. This is yet another reason why most people would NEVER want to be annexed into town. Which as I have often mentioned could be the fastest solution to housing shortages, by annexing out to Monson Lane, as once planned, but no action has been discussed that I have heard to do any of that. Only thing is subsidized

housing. Get out of the way, help the private developer if there are any left in the State to do what the economy can do. Provide jobs and housing.

There was a proposal on the GP site to make them keep the trees on Main Street, I was there and spoke against it, the suggestion did not allow for dead and dying trees, which they mostly are now after 20 some years.

SB9 I have asked but have not heard what can be done to split a city lot under SB9 perhaps someone can reach out to the interested parties, as specified in the still adopted Economic Strategy Plan. Realtors, builder types and others.

BACKGROUND AND OVERVIEW:

Council Member Albin-Smith approached staff regarding the creation of a Tree Advisory Committee and Tree Preservation Ordinance, requesting this item come forward. Albin-Smith provided some sample documents including a summary document of an Advisory Committee and a sample Tree Preservation Ordinance (attachment 1 & 2).

While the City does not currently have a tree preservation ordinance, there are several policies within the General Plan intended to protect, preserve, and plant native tree and plant species. Many communities have tree preservation ordinances with policies ranging from protection of public trees and encouraging new plantings, some mainly focus of safety and hazard mitigation inspections, while others restrict removal of any tree on public or private property without a tree removal permit. A tree ordinance in the City of Fort Bragg would ideally fall somewhere in-between these two models with the goal of controlling the removal of trees to preserve the beneficial impacts that trees provide including preventing erosion, maintaining property values, and for their aesthetic, natural, and historic value. Within the context of our existing codes, do we have the tools necessary to achieve this goal? In addition to the General Plan Policies, other existing City codes, which regulate vegetation protection, planting, and removal, include; Model Water Efficiency Landscaping Ordinance (MWELO), Weed Abatement, Fire Mitigation, and land use Landscaping codes.

The resultant ordinance would ultimately determine how much staff time and resources would be necessary to prepare and implement such a ruling. Estimates from other Cities necessitated up to three (3) additional full time staff members for creation and implementation of a tree ordinance. Most Cities with tree ordinances have a full Parks and Recreation Department, a staff Arborists, and/or a Forestry Management Team. The proposed ordinance will add additional duties and responsibilities to the City's Planning, Code Enforcement, Engineering, and Maintenance Crew staff to review and inspect various types of planning applications, development permits, and maintain the program.

In an effort to further understand and quantify the potential impact of creating an ordinance and tree preservation database, staff reviewed publicly available tree canopy mapping tool provided by the U.S. Department of Agriculture (USDA) https://www.fs.usda.gov/Internet/FSE_DOCUMENTS/fseprd645759.html. According to the 2018 Urban Tree Canopy mapping dataset, census tracts within the City of Fort Bragg average 22%-24% tree canopy with approximately 1,700 acres of canopy. Evaluating, cataloging, and determining the "heritage" value of existing trees alone (as proposed by the tree advisory committee memo) is a significant undertaking.

Where does this ordinance fall within the scope of City priorities? From what fund, should costs be covered? What subject matter experts should be brought in to consult?

RECOMMENDATION:

Make recommendation to City Council if the Committee recommends staff pursue preparation of regulatory framework for tree ordinance.

and species of the trees to be removed, a brief statement of the reason for removal, a plot plan, as well as such other pertinent information the City deems necessary in this investigation. In making a determination in regard to the merits of the application, the City shall base its determination on the following factors:

- Condition of the trees with respect to disease, danger of falling, proximity to existing or proposed structures and interference with utility services;
- 2. Necessity to remove trees in order to construct proposed improvements to allow reasonable economic enjoyment of the property upon which trees are located;
- 3. Topography of land and the effect of tree removal on erosion, soil retention and the diversion or increased flow of surface waters;
- 4. Number of trees existing in the neighborhood on improved property and the effect of said tree removal on said neighborhood;
- 5. Good forestry practices, including, but not necessarily limited to, the number of healthy trees that a given parcel of land will support.
- B. The City shall make an investigation of the site where a tree or trees is or are proposed to be removed within ten (10) days after submittal of the application by the applicant.
- C. In making investigations and in making a determination as to the merits of an application, the City shall give priority to those applications which are based on trees that are hazardous or diseased.

Sec. _____. SUBDIVISIONS; DESIGNATION OF TREES TO BE REMOVED; RETAINED:

All subdivision maps or divisions of land filed for tentative approval shall clearly designate all trees upon the property proposed for subdivision or division. Those trees proposed to be removed and those trees proposed to be retained shall be shown by size and species on said map. The developer shall also mark with paint those trees proposed to be retained in the field and shall protect those trees by fencing or some similar means in order to clearly identify the area where no work is to take place. The City shall only approve trees to be planted from the approved tree list after consultation with a professional arborist or tree advisory committee.

The City shall review trees proposed for removal with respect to their current listing as heritage, legacy, or trees of special value or concern. Any proposed changes of trees to be planted or removed already designated on a tentative subdivision map or other map for the division of property, as filed and approved, shall require an application for a new permit under the provisions of Section ______. Accompanying said map shall be a statement by the developer that it is their intent to maintain those trees proposed to be retained and what procedures he proposes to effectuate such intention.


Sec. ____. RESTORATION, REPLACEMENT OF DAMAGED TREES OR TREES NOT APPROVED FOR REMOVAL:

Any person who damages or destroys a tree that has not been approved for removal under the provisions of Section ____, shall, if said tree has been damaged, restore said tree to its former condition under the direction of, and to the approval of, the City, or shall, if said tree is not able to be restored to its former condition, or has been destroyed, replace said tree within one year after a determination by the City that said tree is not able to be restored to its former condition, or within one year after the destruction of said tree, with a tree that has been approved by the City.
