RESOLUTION OF THE FORT BRAGG CITY COUNCIL APPROVING THE ESTABLISHMENT OF CV STARR MANAGER MID-MANAGEMENT CLASSIFICATION AND PUBLIC WORKS ADMINISTRATIVE ASSISTANT FORT BRAGG EMPLOYEE ORGANIZATION CLASSIFICATION AND CONFIRMING THE PAY RATES/RANGES FOR ALL CITY OF FORT BRAGG ESTABLISHED CLASSIFICATIONS

WHEREAS, the City is currently cooperating with Mendocino Coast Park and Recreation District (MCPRD) to facilitate the transfer of the CV Starr Center operations to the City; and

WHEREAS, Moneque Wooden served as the Mendocino Coast Park and Recreation District Administrator for 2.5 years and was responsible for District management as well as the overall management of the CV Starr Community Center; and

WHEREAS, in May 2023, Moneque Wooden applied for, was appointed, and has worked as a Public Works Administrative Analyst through July 31, 2023, but once MCRPD cancelled the City-District Operating Agreement on August 2 2023, it was necessary that Ms. Wooden revert back to managing CV Starr; and

WHEREAS, the current Classification and Salary Schedule does not currently include a classification to manage the CV Starr Center and the City wishes to establish the Mid-Management, exempt, non-bargaining CV Starr Manager classification and appoint Ms. Wooden as CV Starr Manager; and

WHEREAS, Public Works wishes to add an additional position of Administrative Assistant, which will be part of the Fort Bragg Employee Organization (FBEO) bargaining unit and is not confidential; and

WHEREAS, the additional Public Works Administrative Assistant will not require a Budget Amendment at this time since the current Administrative Analyst is vacant; and

WHEREAS, the Fort Bragg City Council approves all new classifications and salary schedules, which include classification titles and compensation rates as reflected in Exhibit A; and

WHEREAS, the establishment of this Resolution meets the requirements of California Code of Regulations Section 570.5 as confirmed by CalPERS; and

WHEREAS, the Fort Bragg City Council approved the latest salary schedule through Resolution 4705-2023, adopted July 10, 2023, which established salary schedules for all Employees; and

WHEREAS, the California Public Employees' Retirement System code requires the City to have a publicly adopted and posted salary schedule; and

WHEREAS, the full salary schedule is allocated in the proposed FY 2023/2024 budget and the full salary schedule is available on the City's website

NOW, THEREFORE, BE IT RESOLVED that the City Council of Fort Bragg does hereby adopt the City of Fort Bragg Master Salary Rate Compensation Plan as presented in "Exhibit A" effective July 30, 2023.
