Regarding the appointments of Mr. Lee and Mr. Norvell:

1. The Council should move forward with the appointments, but *\*only\** for a maximum of TWO YEARS, not the full term.
2. At the latest, the election should be wrapped into the next City Council election in 2022, electing all five Council seats together.

It is certainly reasonable to want to save the \$10,000 to hold the unopposed election. It is also reasonable that, being unopposed, voters be allowed to focus their energy on other races this November.

However, it must be understood that the absence of challengers during a world-wide pandemic and the throes of a national racial justice reckoning *\*cannot\**, and *\*must not\**, be taken as an affirmation of Mr. Lee and Mr. Norvell's work as Council members or as a mandate of the people. It is merely a testament to the fatigue, fear, and distraction by the people of Fort Bragg, especially BIPOC, who have the work of ongoing racial justice efforts weighing extra heavily right now.

The people of Fort Bragg still have a right to an election, even if it is delayed. Two years is enough time for our world to stabilize to its new normal, and places the next election with the three other Council seats.

Councilmembers [via BCC],

I read the public comments that were posted this morning about the potential appointment of of Will and Bernie to fill their current seats that are up for election in November. Many people are calling for a shorter two-year appointment probably relaying on the provisions on Elections Code section 10229, subd. (d) that was uploaded to the agenda packet along with the public comments. The City has not yet elected to pursue that option and adopt an ordinance that allows us to make Council appointments pending a special election and I do not believe we have time to adopt one prior to the November election to allow us to use it this time. That said, we probably should have adopted this ordinance this spring when Lindy was running for Supervisor and there was the possibility that his seat would have been vacant. The fact that we did not is an example of us dropping the ball and experiencing unintended consequences that could have been avoided (i.e., having appointed rather than elected Council members when the people could have had the opportunity to vote for the candidates of their choice at an earlier opportunity). Of course, it is entirely possible that we will have a different election system in place prior to the 2022 Council election anyway but the appointed versus elected Councilmember issue will remain regardless. I recommend that the Council pursue a simple ordinance to allow the City Council and voters the option of shorter appointments followed by special elections. If we had done this a few months back, it would already be in place and the option some people are calling for would have been available to us today.

To the Honorable Members of the Fort Bragg City Council & Mayor Will Lee

I note the usual civic killjoys want the city council to amend election law during tonight's special meeting to reduce the four-year city council terms of Will Lee & Bernie Norvell to "two years" because of "fatigue, fear, and distraction by the people of Fort Bragg." They added, "Two years is enough time for our world to stabilize to its new normal, and places the next election with the three other Council seats."

But there is also a better idea circulating. If the council is entertaining amending election law, the city should adopt a "Benevolent Dictatorship" form of city government.
