 6 months to get something in the water.
- Water Treatment Plant Rehabilitation Project- Will be out to bid soon.
- Pudding Creek Water and Sewer Line- Is complete and secured to the new bridge.
- Raw Water Line Project- Out to bid on November 16, 2023.

- Reservoirs Project- Working on funding source and design.
- Distribution System Rehabilitation Project- Working with consultants and will have a layout of all systems.
- Water Meter Replacement Project- Moving forward slowly, change in ownership of the company, which caused complications and delays.
- Recycled Water Feasibility Study- Waiting on the funds to be awarded.
- Collection System Assessment- Working with same consultants as Distribution System Project.
- Wastewater Treatment Plant Projects- Sodium hypochlorite generators ordered. Dryer building needs a rehab. Need a bio solids storage building.
- Elm Street Pump Station Project- Plumbing complete.
- Stormwater Trash Capture Devices- Working on applying for grant funds.
- CleanCal Art & Recycle Project- Grant funding for new trash cans with local art.
