Dear Sirs.

I am writing to you with regard to the new Grocery Outlet store that has been proposed for construction and operation on the 800 block of South Franklin Street in Fort Bragg, directly across the street from my house. My intention here is to set forth a number of reasons why permission to build and operate that proposed new store should be denied.

I have owned my home here on the northeast corner of North Harbor Drive and South Franklin Street since 2000. As you assuredly recall, a number of years ago, I led a successful community drive to block construction of a new Dollar Tree store on exactly the same site now proposed for construction and operation of a new Grocery Outlet store. The reasons why the majority of my neighbors and I opposed the construction of that Dollar Tree store back then are exactly the same reasons why we now oppose the new Grocery Outlet store whose application for a Use Permit is under your consideration.

Those reasons are as follows:

- 1) grave impediment to emergency vehicles going to and from Mendocino Coast District Hospital (MCDH) along South Street, which passes directly by the northern corner of the lot on the 800 block of South Franklin Street that has been proposed as the site for the new Grocery Outlet. Incidentally, the intersection of South Street and South Franklin Street, just one block north of my home, is already notorious for having an inordinately high rate of traffic accidents. I and my neighbors legitimately fear that the additional heavy traffic that will inevitably be generated by customer and delivery vehicles going to and from the proposed Grocery Outlet will simply exacerbate that pre-existing hazardous traffic situation at South Street and South Franklin Street.
- 2) Furthermore, that same inevitably dramatic increase in the vehicular traffic on North Harbor Drive, South Franklin Street, South Street, and other neighboring streets that would ensue from construction of the proposed new Grocery Outlet store would generate a whole series of other grave safety, health, environmental and quality of life risks in what fundamentally is still a <u>residential</u> neighborhood, notwithstanding the mixed-use zoning prevalent in this area. Everyone living or temporarily staying in my neighborhood at its various hotels and motels will be impacted by these various risks:
 - a) a dramatic increase in air pollution produced not only by passenger vehicles but especially by the delivery vehicles, many of which will be diesel tractor trailer rigs. It is common knowledge that the particulate generated by the combustion of diesel fuel in vehicles constitutes a grave

- health risk, measurable in terms of increased incidence in cancer, asthma, and other serious if not fatal diseases;
- b) a dramatic increase in noise pollution. As you might already know, I have filed numerous complaints over the years with the Fort Bragg Police Department and Fort Bragg City Hall against the recurrent noise produced by the tractor trailer delivery trucks that frequently but illegally park in the empty lot directly across from my home and abutting on the rear side of the Super 8 Motel located at the corner of North Harbor Drive and Main Street. That noise is generated by the truck generators and refrigeration units in their trailers which typically, but illegally, run all night, negatively impacting the sleep of neighbors for at least a two-block radius. That fact can be confirmed both by the Fort Bragg Police Department and even by the Mayor of Fort Bragg, Mr. Bernie Norvell, whose own nighttime slumber was disturbed in consequence of one such incident that occurred in the wee hours of Wednesday, April 7, 2021. Moreover, those relatively few tractor trailers that currently travel along our neighborhood streets already generate a significant amount of noise. Those problems would inevitably increase dramatically if the proposed new Grocery Outlet were granted a construction permit and Use Permit;
- c) That increase in noise would necessarily be accompanied by a drastic increase in congestion on around my house and on neighboring streets. North Harbor Drive already experiences heavy traffic at certain hours and on certain days. North Harbor Drive constitutes the ONLY access to the northern side of Novo Harbor. That unavoidable route, connecting Main Street / Highway I to the west with the harbor and its dense assemblage of private homes and apartments, hotels, restaurants and bars, stores, professional fishing establishments, workshops to the east, and at the end, Noyo Harbor Beach, already attracts very heavy traffic on the weekend, and in the peak summer tourist season, virtually every day. All of that traffic passes directly in front of my house, which sits at the intersection of North Harbor Drive and South Franklin Street. As you know, that T intersection is already highly problematic due to the obstinate failure of numerous motorists to obey the stop signs, the choke point represented by the availability of only one lane of traffic in either direction, and the aforementioned heavy traffic volumes at peak hours. Incidentally, these same traffic problems already make it difficult, if not even dangerous, for me and my family members to enter and pull out of our driveway on the South Franklin Street side of my property. The same could be said for certain other residences along both streets in the vicinity of my house. Now, it is obvious that those problems will only be compounded in future if the proposed Grocery Outlet is granted permits for construction and business operation, due to all the additional vehicular traffic going to and from that proposed store, which simply does not even exist at present. Inevitably, a stoplight would have to be installed at the intersection of North Harbor Drive and South Franklin Street, and probably also at the intersection of South Street and South Franklin Street and at the intersection of Main Street and North Harbor Drive, simply to regulate the enormous increase in traffic volume generated by that proposed Grocery Outlet store and prevent the inevitably dramatic increase in vehicular collisions and even vehicular-pedestrian collisions along the streets around my home and neighborhood. Past traffic analyses of my neighborhood that were prepared on the assumption that first the Dollar Tree and now the Grocery Outlet would be constructed have repeatedly borne out my assertions made above and the consequent inadvisability of allowing the construction and operation of such a retail establishment on the 800 block of South Franklin
- d) law and order problems would also ensue from the operation of such a large discount retail grocery store: the proposed Grocery Outlet would in all likelihood (as the present situations existing at the nearby Safeway store, Rite-Aid Drugstore, and CVS store amply confirm to any passerby) attract loiterers, the homeless, and a dramatic increase in litter in our neighborhood, where such problems are presently minor or non-existent. To repeat, our neighborhood is primarily residential, and currently suffers "only" from the existing traffic nuisances and the

weekly Tuesday night noise caused by the delivery trucks persistently parking illegally in the empty lot on the northwest corner of North Harbor Drive and South Franklin Street. The truck drivers responsible for those recurrent infractions are simply brazen, recidivist lawbreakers who collectively constitute a red flag warning of what will definitely ensue if the Grocery Outlet store is allowed to be built and operate. It is unthinkable that if even now, with just two or three tractor trailer rigs that illegally park across the street from my house one night a week, directly across the street from the Harbor Lite Inn, and just a few feet behind the guest rooms at the Super 8 Motel, disturbing the peace and slumber of one and all for a two block radius, notwithstanding repeated Police interventions and warnings, the noise and traffic problem here would do anything other than worsen were the Grocery Outlet be allowed to open;

e) consequent to the problems associated with the list of claims made above, the value of my home and yard will necessarily be impaired. It is fair to assume that if the new Grocery Outlet store project is allowed to proceed on South Franklin Street, the present value of my property will be reduced to its tear-down value, thereby obviating the enormous investment of time, energy, and money that I have made in my home and garden over the last 21 years.

So, to conclude: the proposed construction and operation of a Grocery Outlet store on the 800 block of South Franklin Street can only worsen the quality of life and safety of surrounding residents and visiting tourists in the nearby hotels and motels, and either create new hazards or severely exacerbate pre-existing ones (slowing down or blocking emergency vehicles going to and from the MCDH along South Street, aggravating the at times already heavy traffic on North Harbor Drive and South Franklin Street, aggravating existing noise problems, etc.).

I humbly submit these critical issues to your attention and earnestly hope that you will accord them the ponderous consideration that they merit in the context of any decision on whether to grant the proposed Grocery Outlet store a building permit, use permit and any other form of official authorization as might be necessary for that business establishment to commence operations.

Gross Out isn't a full service supermarket anyway, so people will still need to buy at the other stores. It's a supplement to traditional supermarkets, not a replacement for them. Most importantly, though, the existing stores need some force pushing their prices down. So maybe them losing a little business and then adapting wouldn't be a terrible thing.

The location. Let's admit the obvious: whatever location was proposed, they would find fault with it. Their claims of traffic chaos and widespread gridlock from a not-very-big grocery store on a major street a block from the highway are hyperbolic at best, comically silly at worst. Objections to the headlands location made sense, but it'd be hard to find a better location on the coast than the neglected old Social Services Building. Furthermore, many of the people telling tall tales about traffic chaos turn around and argue that a discount discount store is not needed on the coast, since we have numerous other grocery options. They need to pick one argument and stick with it instead of contradicting their own point. If the project isn't needed, there won't be a traffic problem. If there's a traffic problem, it's because the project is so desperately needed. More likely scenario: the business will be busy, but existing roads can handle the traffic just fine.

Instead of making grandiose dogmatic proclamations about banning all chain stores, we should instead evaluate each proposal on its merits. The coast needs lower food prices, and Grocery Outlet can help reduce that problem. The old social services building is the best available location. The proposal should be approved.

Grocery Outlet is not a good bet for our city nor the coastal community. As a resident and a voter, I encourage you to ban all Big Box, Formula Outlets like Grocery Outlet and Dollar General.

Since this hearing is about Grocery Outlet- I put forth for your review the following info that pertains to Grocery Outlet. Unlike a Harvest Market or even chains like Safeway, or Wal-Mart, Grocery Outlet's offerings often change from month to month depending on what items are available. So only about 20% of the merchandise are items you'll find every single visit.

Please review the following and I hope that you are convinced that Grocery Outlet is not a stable or sure bet business model for Fort Bragg. We do not need any more abandoned big buildings in Fort Bragg (where housing could go) when corporate businesses decide to move out or go belly up. There was a Grocery Outlet in Berkeley CA and that was shut down several years ago since a developer obtained the property for housing development.

Market watchers and Wall Street are not convinced that Grocery Outlet is on the right path-and are unsure of the long-term direction of the company. See articles below.

In addition,

The site of the proposed Grocery Outlet will generate hundreds of new car trips per day along S. Main Street and N. Harbor Drive and South Street which are also the entryways to the busy assorted medical offices, Adventist Hospital Emergency Room & facilities, Mendocino Coast Clinics as well as Noyo Harbor restaurants and shops. It's hard enough already, even during COVID, to try to get down to Noyo Harbor or back on to South Main Street.

Consider how much more traffic will be added to the mix and the road wear is considerable if we add hundreds of cars going in and out of this Grocery Outlet at these busy intersections every day. The proposed Grocery Outlet also raises concerns about storm water runoff, public safety, crime and more alcohol sales.

From an economic perspective, there is much data to suggest that corporate owned big box chain stores may not be the best value for our community in terms of how they undercut all the community-based markets already in place such as:

These local businesses invest heavily in their employees and make assorted value-based contributions to community non-profits and projects. They will be undercut by Grocery Outlet. Do you really see that as a good plan?

We also have plenty of discounts at CVS, Rite Aid and a Dollar Store.

Grocery Outlet does not offer franchise opportunities. Grocery Outlet's independent operators operate Grocery Outlets locations for Grocery Outlet. Independent Operators are business entities that hire, train, and manage for Grocery Outlet and then Corporate shares the profits of the retail store according to Grocery Outlet's commission structure. Both entities each assume different risks.


Chain store proliferation has weakened local economies, eroded community character, and impoverished civic and cultural life. Moreover, consolidation has reduced competition and may harm consumers over the long-term. Contrary to conventional wisdom, the decline of independent businesses is not inevitable, nor is it simply the result of free market forces. Rather, public policy has played a major role, particularly through tax incentives and other development subsidies that give national chains a significant advantage. Meanwhile, a growing number of communities are taking a different approach. They are adopting land use rules that deter chain stores and actively encourage local ownership. Not independent contractor franchises.

Even the most competitive, efficient, and popular independent businesses are struggling to stay afloat. What is clear is that the loss of independent businesses is not inevitable. **Rather than undermining the local economy, many communities are taking a different approach.** They have made sustaining humanly scaled, unique homegrown businesses a primary focus of planning and economic development decisions.

They are adopting a variety of land use rules that deter chain stores and foster local ownership. Many have restricted the physical size of new stores. Others allow new retail development only if it meets specific criteria defined by the community. Some have banned uniformity, by

prohibiting "formula" businesses. Others have barred new retail development outside of the town's central business district. (Examples of these policies, including the full text of the local ordinance, can be found on the New Rules web site, created by the Institute for Local Self-Reliance, at "At the root of much of rural America's distress is the concentration of economic and financial power," ILSR Co-Director Stacy Mitchell testified before the U.S. Senate Banking Committee on Tuesday, April 20th.

Grocery Outlet (NASDAQ:GO) is a discount retailer that sells food products from name-brands and each location is independently operated. The company has seen impressive growth for almost two decades, and the company now operates 362 stores in six different states. The company's stock has moved within a relatively small range since its IPO.

Grocery Outlet: Lagging in All Aspects

We believe that the company is overvalued at the moment, as it is trading at 38.86x earnings despite facing many short and long-term risks. The competition landscape, as well as overall trends in the food supply chain, suggest that Grocery Outlet may see difficulty growing in the long run. Grocery Outlet cannot control supply, and operational efficiency of suppliers is bound to go up in the long run summation, we are unsure of the long-term direction of the company. The company does not pay dividends for obvious reasons, and we believe the increased competition landscape and general consumer trends will greatly disrupt Grocery Outlet's growth. The company trades at a P/E ratio of about 37x, which is a bit high for a purely retail operation.

Moreover, since Grocery Outlet generally does "not have long-term contractual agreements with our suppliers that obligate them to provide us with products exclusively or at specified quantities or prices, or at all" (GO 10-K, 2020), suppliers can easily make decisions that leave Grocery Outlet to dry and have no consequences of doing so. For example, operational giants such as Amazon and Walmart may begin to purchase excess inventory from suppliers for higher prices and longer-term contracts than Grocery Outlet simply because they have the network and resources to do so, even if this inventory will not end up in grocery stores - digital grocery shopping opens a world of opportunity. Suppliers are not tied down by contractual obligations with Grocery Outlet, therefore will take the better deal outright

Grocery Outlet stock has fallen 11.6% for the year to date while the S&P 500 index SPX, -0.21% is up 9.5% for the period.

Dollar stores frequently sell expired or dangerously defective merchandise.

EXAMPLE: On August 26, 2019, New York Attorney General Leticia James <u>announced</u> the culmination of a year-long investigation into the sale of expired drugs (some more than a year past their expiration date) and faulty motor oil, as well as illegal practices regarding New York state's bottle deposit law. The Dollar General-branded motor oil at issue in the investigation was not viable for most engines created after 1930s. Dollar General, Dollar Tree and Family Dollar were collectively fined \$1.2 million dollars.


