RESOLUTION OF THE FORT BRAGG CITY COUNCIL DELEGATING TO THE CITY MANAGER, INTERIM CITY MANAGER AND ACTING CITY MANAGER AUTHORITY OF DISABILITY RETIREMENT DETERMINATIONS OF LOCAL SAFETY OFFICER EMPLOYEES OF THE CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM

WHEREAS, on July 27, 1981 the City Council adopted Resolution 1007-81; a Resolution Delegating Authority to City Administrator for Making Disability Retirement Determinations; and

WHEREAS, on July 27, 1992, Resolution 1911-92 amended the aforementioned Resolution 1007-81; a Resolution Establishing a Procedure for Industrial Disability Retirement Determinations of Local Safety Officer employees of the Public Employees' Retirement System; and

WHEREAS, on January 27, 2020, Resolution 4226-20 amended the aforementioned Resolution 1911-92; a Resolution Delegating Disability Retirement Determinations of Local Safety Officer Employees Covered by the California Public Employees' Retirement System to the City Manager; and

WHEREAS, the City of Fort Bragg (Agency) is a contracting agency of the California Public Employees' Retirement System; and

WHEREAS, the Public Employees' Retirement Law requires that a contracting agency determine whether an employee of such agency in which he/she is classified as a local safety member is disabled for purposes of the Public Employees' Retirement Law and such disability is "industrial" within the meaning of such Law; and

WHEREAS, Fort Bragg City Council has determined upon legal advice that it may delegate authority under Government Code section 21173 to make such determinations to the incumbent of the position of City Manager, Interim City Manager and Acting City Manager.

NOW, THEREFORE, BE IT RESOLVED: That the Fort Bragg City Council does hereby delegate to the incumbent of the position(s) of City Manager, Interim City Manager and Acting City Manager the authority to make application on behalf of the Agency pursuant to Government Code 21152(c) for disability retirement of all employees and to initiate requests for reinstatement of such employees who are retired for disability;

BE IT FURTHER RESOLVED that Fort Bragg City Council does hereby delegate to the incumbent of the position(s) of City Manager, Interim City Manager and Acting City Manager authority to make determinations of disability on the Agency under Government Code section 21156 and whether such disability is industrial and to certify such determinations and all other necessary information to the California Public Employees' Retirement System.
