RESPONSIVE BID, AWARDING THE CV STARR POOL BASIN
RECONSTRUCTION PROJECT, CITY PROJECT NO. PWP-00113, TO EARL
ADAMS TILE-COPING & PLASTERING, INC. DBA ADAMS POOL
SOLUTIONS AND AUTHORIZING CITY MANAGER TO EXECUTE
CONTRACT (AMOUNT NOT TO EXCEED \$237,500.00; ACCOUNT NO. 8104812-0751)

WHEREAS, in accordance with California Public Contract Code 20164 and other applicable laws, the CV Starr Pool Basin Reconstruction Project, City Project No. PWP-00113 (the "Project") was advertised for bid on July 25, 2019 and August 1, 2019; and

WHEREAS, four (4) bids were received for this Project: Adams Pool Solutions, Burkett's Pool Plastering Inc., Natare Corporation and Condor, Inc.; and

WHEREAS, three (3) of the four bids were found to be responsive; and

WHEREAS, Adams Pool Solutions was found to be the lowest responsive and responsible bid; and

WHEREAS, Mendocino County Environmental Health has reviewed the project plans and has found them to be acceptable according to the California Pool Code; and

WHEREAS, funds in the amount of \$350,000 were appropriated in the FY 2019/2020 budget for this activity; and

WHEREAS, based on all the evidence presented, the City Council finds as follows:

- 1. This project is critical to the preventive maintenance of the CV Starr pools.
- 2. The bid of Adams Pool Solutions meets the requirement of the Project bid documents and is considered responsive.
- 3. Adams Pool Solutions holds the required license to complete the project and has the needed experience of similar projects.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Fort Bragg does hereby approve a Project Agreement with Earl Adams Tile-Coping & Plastering, Inc. dba Adams Pool Solutions for the CV Starr Pool Reconstruction Project and authorizes the City Manager to execute the same upon execution by Contractor (Amount Not to Exceed \$237,500.00; Account No. 810-4812-0751).
