

I am writing to share background and community support information regarding the CDBG funded development of sorely needed low income housing at 350 Cypress Street.

As Parents and Friends' project manager for this development, I would also like to share some information about myself. I am a resident of Fort Bragg and a parent of a Fort Bragg High School student who was born and raised here. Since relocating to the coast 20 years ago I have been living out my true calling by coordinating and providing services for many vulnerable residents in our community. Prior to joining PFI in 2012 I have worked locally at the Cancer Resource Centers of Mendocino County as a Patient Navigator and Consultation Planner, volunteered countless delightful and sometimes heartbreaking hours in our Fort Bragg K-8 schools, and served on the board of the Safe Passage Family Resource Center. While living and working here, I have learned through experience that unfortunate situations can glean hope, and positive change can happen. It takes people working together to look out for one another. *Our Fort Bragg city council and staff, community members, and Parents and Friends are working together to bring hope and change through the Cypress Street housing project.*

The project concept was developed in conjunction with Community Development staff and approved unanimously by the City Council to apply for Community Development Block Grant (CDBG) funds from the state. The project met the challenging grant criteria of being shovel ready, and providing housing and public service for extremely low income disabled and senior citizens.

A CDBG grant application was submitted to the state in 2017 by the City of Fort Bragg, the grant was awarded in 2018, and when the grant funding became available we pushed forward. Despite the pandemic the Coastal Development Permit Application was filed in October 2020.

The CDBG grant pays only for Construction activity costs, and the funds are administered by the City of Fort Bragg. Parents and Friends, Inc. receives zero grant dollars to facilitate this development.

The project contributes a solution to the city's shortage of low income housing by providing homes for up to 12 individuals through an unmet need: that is, specialized supportive housing and services for adults age 59 and older who have a developmental disability and an aging-related condition such as Alzheimer's or dementia.

There is a great need for these specialized supports and ADA housing that allow our disabled seniors to remain in our community as they age and their needs change. I have enclosed 2 of the letters of support that were included in the original CDBG grant application that I would like to explain.

Dr. John Cottle, then Medical Director of Sherwood Oaks Nursing Facility made clear in his letter of support for the project that his staff was not trained or equipped to safely and securely provide the type of care that is required for developmentally disabled persons.

Judith Gage relocated to Fort Bragg 16 years ago specifically to engage her adult son Antony in the 24-hour care services that Parents and Friends provides. In her letter of support, Judy explained that as her son, along with many others who live and work here continue to age they will need the type of care that is proposed by the project. Sadly, Ms.Gage passed away earlier this year. Her hope was for Antony to have a safe place to remain in our community as he ages.

Over the years, this housing project has had the support of Fort Bragg City Council, our mayors, Community Development staff, and community members who live and work here on the coast.

We would like to carry this project forward and contribute positive change to the housing and care needs of our most vulnerable community members. Simply stated, developing 12 new low income housing opportunities on an unused lot in town is good for Fort Bragg now and into the future.





Please disregard or forward this if you are not the right person since I think this project was assigned to M-Group but I have a couple of thoughts about that project, which is up for PC review on the 19th. Anyway, I am happy to have a project with no major concerns and which I feel is basically consistent with the Coastal General Plan (CGP). This is primarily due to the retention and protection of the cypress trees on the site, which would have been a major concern had they been proposed for removal. That said, when I reviewed the project materials you provided to me at City Hall on the 6th, I noticed two items that might merit a special condition to ensure full consistency with all applicable policies of the CGP.

First, the landscaping plan sheet includes a note at the top right side of the page which states "All existing trees to remain and be protected in place throughout construction. Any existing tree in poor health, or considered a hazard as defined by a certified arborist shall be removed and replaced with a similar tree." I am concerned that this note on the plans, the details of which usually become part of the project approval, may be interpreted to permit the property owner and applicant to remove existing trees without City approval. Normally removing a mature tree in the City's Coastal Zone requires a Coastal Development Permit (CDP) because it has been defined as "major vegetation removal." That usually requires specific Planning Commission approval, although I might be mistaken and staff might be the first-level review authority. I don't want the applicant to remove any of the trees, which are also the namesake of Cypress Street.

I think a special condition is prudent to explicitly require Planning Commission approval (or maybe staff-level Administrative CDP approval) prior to any such tree removals. This would require some sort of notice of pending action to alert the public to potential removal of any of these mature trees, which are visible from all over town. I think this is necessary to make sure that these particularly prominent trees, which may have historic significance as well, aren't impacted by this project and that this project remains consistent with the CGP. (I also think the CEQA exemption is only soundly applied to this project if none of these trees are harmed by the project.) Obviously, if one of these trees is actually dangerous, it should be removed but I want to be sure it only happens after a public process with an opportunity for the public to object.

Second, I would like to ensure that the City defines what is expected by the requirement that trees are protected in place throughout construction. There is a tree protection zone based on the drip line but Building #1 is actually a little within that protection zone and I am concerned

that construction activities might impact the root structures of the mature trees. Normally, I would advocate for specific and detailed mitigation measures (e.g., the requirement for hand tools or air spades for any work that could impact the trees root structures within the protection zone as well as a prohibition on severing any existing roots greater than 1.5" or sometimes 2" in diameter regardless of their location). I usually also advocate for the installation of root growth barriers around a building's foundation as well to prevent conflicts between the trees and infrastructure. I find specific special conditions or mitigation measures are almost always better than vague and ambiguous references to "best management practices." I am also generally opposed to applicant-provided biological or arborist studies and would recommend that the City ask for recommendations on special condition wording from Asa Spade, who prepared the original report at Amy Wynn's office.

Finally, I almost never see reference or analysis concerning the City's CGP policy requiring permeable paving materials and would like the requirement to use permeable or porous hardscaping and paving materials for relevant areas on the project plans. That would ensure consistency with that policy (which should probably be required for the Highway One pedestrian infrastructure projects like the one you presented last night even though it wasn't mentioned in the discussion).
