**RESOLUTION OF THE FORT BRAGG CITY COUNCIL
AUTHORIZING THE PURCHASE OF NINE NEW DUAL STREAM WASTE
RECEPTACLES AND TWENTY SETS OF REPLACEMENT ART-WRAPPED
DOOR PANELS FROM MAX-R (AMOUNT NOT TO EXCEED \$48,042.35)**

WHEREAS, the City of Fort Bragg is committed to maintaining clean and aesthetically pleasing public spaces by providing access to eye-catching waste and recycling receptacles with a consistently recognizable appearance; and

WHEREAS, the installation of these receptacles is part of a broader initiative to improve waste management infrastructure and support the City's mission to preserve natural beauty, support tourism, and enhance community life; and

WHEREAS, the City has identified a need for additional waste and recycling receptacles in the Downtown Central Business District (CBD); and

WHEREAS, the trash and recycling receptacles purchased from Max-R in 2018 and 2020 are performing well in the CBD and the City would like to replace the rest of the failing receptacles, add capacity, and maintain a common aesthetic in the area; and

WHEREAS, the Max-R receptacles already in place in the CBD will be renovated with new doors that are wrapped in art that has been created by students of the Fort Bragg Unified School District, thereby promoting environmental stewardship and community pride; and

WHEREAS, In 2023, the City applied for, and received, a grant from the Caltrans Clean California Local Grant Program to curate and install new and/or renovated eye-catching art-wrapped dual stream waste/recycling receptacles; and

WHEREAS, Caltrans Clean California Local Grant Program funds in the amount of \$280,000 are appropriated in the FY 2024/25 budget for activities associated with this grant and sufficient funds are available for this contract; and

WHEREAS, the Project is exempt pursuant to the California Environmental Quality Act ("CEQA") and Title 14, the California Code of Regulations ("CEQA Guidelines"), Section 15301 (c) and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Fort Bragg does hereby approve the purchase of nine new dual stream waste receptacles and twenty sets of art-wrapped replacement door panels from Max-R for the Fort Bragg Art and Recycling Beautification Project and authorizes the City Manager to execute the same (Amount Not to Exceed \$48,042.35).
