Continue Public Hearing and Consider Adoption of a Resolution of the Fort Bragg Planning Commission Recommending that the City Council Establish Regulations and Standards for Outdoor Dining by Amending Division 18 of the Fort Bragg Municipal Code and its Subchapter 18.42.165 Restaurants; and

Adopt a Resolution of the Fort Bragg Planning Commission Recommending that the City Council File with the Coastal Commission an LCP Amendment Application to Establish Regulations and Standards for Coastal Area Outdoor Dining and Amend Division 17 Article 4 of the Fort Bragg Municipal Code and its Subchapter 17.42.190 - Restaurants; and Mitigated Negative Declaration and Statutory Exemption.

Chair Logan continued the Public Hearing at 6:04 p.m.

Consultant Jones presented the report. Commissioners asked clarifying questions regarding procedure of reopening a public hearing, correction of restaurant name, water usage metrics, public comment regarding capacity fees, mitigation measures in environmentally sensitive habitat areas, the definition of outdoor dining, and the definition of a pavilion.
