SUBJECT: Suggested 2024 Schedule for Regular Planning Commission Meetings

Background: The March 22, 2023 adopted bylaws establish that regularly scheduled Planning Commission meetings fall on the second and fourth Wednesday of each month, with some exceptions when dates conflict with holidays. Whereas, Fort Bragg Municipal Code Section 2.20.060 MEETINGS - MAINTAINING PUBLIC RECORD states:

The Planning Commission shall meet at least once a month at the time and place as it may fix by resolution, and shall cause a record to be kept of all of its proceedings, which record shall be a public record. Staff shall be the body utilized by the Commission to cause the record to be made.

Be assured that whether a regular meeting is held or cancelled, Community Development Department staff facilitate notices, distribution of reports, and use of Town Hall. During 2023, seven meetings were held and eighteen meetings cancelled. In 2022, twelve meetings were cancelled and in 2021, eleven meetings were cancelled. The following lists potential 2024 meeting dates. Planning Commission meetings will not be scheduled on November 27 nor December 25.*
