RESOLUTION OF THE FORT BRAGG CITY COUNCIL APPROVING PROFESSIONAL SERVICES AGREEMENT WITH DE NOVO PLANNING GROUP TO INCREASE THE CONSULTANT'S TOTAL COMPENSATION AND AUTHORIZING CITY MANAGER TO EXECUTE CONTRACT FOR A THIRD AMENDMENT (AMOUNT NOT TO EXCEED \$67,498.00)

WHEREAS, the City and Consultant entered into a Professional Services Agreement ("Agreement") on April 26, 2022 to prepare an Environmental Impact Report for the proposed Grocery Outlet at 825, 848 and 851 South Franklin Street, pursuant to City Council Resolution 4538-2022 adopted April 25, 2022; and

WHEREAS, the City and the Consultant executed a First Amendment to the Agreement on September 23, 2022 increasing the scope of work, and a Second Amendment to the Agreement on February 17, 2023 extending the time for completion; and

WHEREAS, the initial contract Paragraph 2.1 states "Compensation. Consultant's total compensation shall not exceed Fifty-six Thousand Thirteen Dollars (\$56,013.00); and

WHEREAS, the first contract amendment included an agreement to amend contract Paragraph 2.1 as follows, "(Compensation) is hereby amended to state that total compensation shall not exceed Fifty-eight Thousand Seventy-three Dollars (\$58,073.00); and

WHEREAS, on the 5th of June 2023, City Council held a special meeting to adopt a resolution certifying the Environmental Impact Report for the Best Development Grocery Outlet (Sch: 2022050308) and adopt the California Environmental Quality Act Findings and the Mitigation Monitoring and Reporting; and

WHEREAS, the Consultant and the Project Planner completed Additional Work on the FEIR that was unexpected and beyond the scope of the original Contract as amended; and

WHEREAS, the Consultant has requested compensation for Additional Work on the FEIR in the amount of Nine Thousand Four Hundred and Twenty-five Dollars (\$9,425.00); and

WHEREAS, City and Consultant desire to amend the Contract to include the completed Additional Work on the FEIR; and

WHEREAS, there are still sufficient funds budgeted for these activities which will be paid by the applicant through their Developers Deposit Account (DDA 119-0000-2668).

NOW, THEREFORE, for the aforementioned reasons and other valuable consideration, the receipt and sufficiency of which is acknowledged, City and Consultant hereby agree that the Professional Services Agreement for preparation of an Environmental Impact Report for the proposed Grocery Outlet between City and Consultant dated April 26, 2022, is hereby amended as follows:

1. Compensation and billing:

Paragraph 2.1 (Compensation) is hereby amended to increase the Consultant's total compensation shall not exceed **Sixty-seven Thousand Four Hundred and Ninety-eight Dollars (\$67,498.00)**;

2. Except as expressly amended herein, the Professional Services Agreement between the City and Consultant dated April 26, 2022, as amended by the First Amendment to Agreement dated September 23, 2022 and by the Second Amendment to Agreement dated February 17, 2023, is hereby reaffirmed.

NOW, THEREFORE, BE IT RESOLVED that the City Council of Fort Bragg does hereby approve this resolution to approve a Third Amendment to the Professional Services Agreement with De Novo Planning Group to increase the Consultant's total compensation not to exceed **Sixty-Seven Thousand Four Hundred and Ninety-Eight Dollars (\$67,498.00).**
