JIM HURST BIO

Jim and his wife Barbara have resided in Fort Bragg since 1978 when they returned to assist Barbara's mother Gladys Johnson and sister Judie Moilinen in the operation of the Harbor Lite Lodge. They have two children, Erik who lives in Tahoe City and Jason who lives in Fort Bragg with his wife and two daughters. Jason manages the Harbor Lite Lodge. Barbara was born and raised in Fort Bragg.

Jim worked in healthcare and child care businesses in Michigan before moving to Fort Bragg and was Director of Research for the California State Assembly from 1974 to 1978. He graduated from Chico State in 1963 and the Coro Foundation for Public Affairs in 1964. He earned a Masters of Public Administration from Golden Gate University in 1974. Jim and Barbara were born in 1941.

Community involvement has been a significant part of Jim's work on the Mendocino Coast including co-founding the Coast Youth Soccer League, the Botanical Gardens Preservation Corporation, and the Hospital Foundation. He served on the Mendocino Coast Recreation District Board for 3 years and the Fort Bragg School District Board for 18. He managed the Recreation District and Starr Center in 2010 and 2011 as a volunteer and was directly involved in the passage of the sales tax to support the Starr Center operation. He has served on numerous bond campaigns for the School District over the past 40 years. Jim currently serves as a Noyo Harbor Commissioner and is a member of the Hospital Measure C Oversight Committee.

On the business side Jim was the Fort Bragg representative on the Mendocino County Lodging Association for 3 years and served as President in 2005. In addition to owning the Harbor Lite Lodge, Jim and Barbara are partners with the Canul family in Silver's at The Wharf and Anchor Lodge in Noyo Harbor.
