**RESOLUTION OF THE FORT BRAGG CITY COUNCIL AMENDING THE
MASTER SALARY COMPENSATION PLAN TO ADD TWO
CLASSIFICATIONS INCLUDING PAY RATES AND RANGES EFFECTIVE
OCTOBER 20, 2024**

WHEREAS, the Fort Bragg City Council approves all new classifications and salary schedules, which include classification titles and compensation rates as reflected in Exhibit A; and

WHEREAS, the establishment of this Resolution meets the requirements of California Code of Regulations Section 570.5 as confirmed by CalPERS; and

WHEREAS, the City of Fort Bragg was awarded funding in 2023 from the County of Mendocino to operate the Extreme Weather Shelter (EWS) for two years, and that award included funds for a part-time Office Assistant to assist with the EWS; and

WHEREAS, the City of Fort Bragg has been tentatively awarded funding from the Proposition 47-Cohort 4 intended to expand treatment for mental health and substance use disorders on the Mendocino Coast; and

WHEREAS, the Proposition 47 award includes funding for a part-time Grants Analyst to coordinate grant deliverables and funding for the duration of the grant; and

NOW, THEREFORE, BE IT RESOLVED, FOUND, AND DETERMINED as follows:

1. The Recitals set forth above are true and correct and are incorporated herein.
2. The City of Fort Bragg Master Salary Rate Compensation Plan is amended to add the following two classifications, inclusive of pay rates and ranges more specifically set forth in the Fort Bragg Master Salary Rate Compensation plan, as amended, attached as Exhibit A:
 - a. Grants Analyst (Part-Time, Less than 20 hours week; Grant Funded, At-Will); and
 - b. Office Assistant (Temporary Position)
3. This Resolution has been reviewed with respect to the applicability of the California Environmental Quality Act (Public Resources Code Section 21000 *et seq.*) ("CEQA"). It is determined that the approval of this Resolution does not have the potential for creating a significant effect on the environment and is therefore exempt from further review under CEQA pursuant to State CEQA Guidelines Section 15060(c)(3) because it is not a project as defined by the CEQA Guidelines Section 15378. Adoption of the Resolution does not have the potential for resulting in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment.
