CALL TO ORDER

Mayor Norvell called the meeting to order at 6:00 PM, Councilmember Albin-Smith and Vice Mayor Morsell-Haye appearing via video conference.

AGENDA REVIEW

1. MAYOR'S RECOGNITIONS AND ANNOUNCEMENTS

Mayor Norvell congratulated the Fort Bragg High School softball team for advancing to the Division IV playoffs.

3. STAFF COMMENTS

City Manager Spaur thanked staff members Sarah McCormick and Cristal Muñoz for their work on organizing the Blue Economy Symposium. Mr. Spaur gave an oral summary of the adjusted annual base salary of \$195,000 for the new City Manager position.

4. MATTERS FROM COUNCILMEMBERS

Councilmember Peters said the Blue Economy Symposium was very professional and well organized, stating that the ocean is a great resource for its economic potential. He noted that the Fort Bragg Fire District Board meets tomorrow night to approve the budget and that the Fire Department has a new fire truck. Councilmember Rafanan said the Blue Economy Symposium was a great success and thanked Sarah McCormick for her work on the event. Vice Mayor Morsell-Haye said the Blue Economy Symposium has an emphasis on restorative, not

exploitative, industry and that we are proceeding with healthy ecosystems in mind. Councilmember Albin-Smith echoed the comments about the Blue Economy Symposium event. Mayor Norvell reminded the public that this is the last hybrid meeting and that starting in June, City Council and Planning Commission meetings will take place in person.

5F. 22-243 Approve City Council Letter in Opposition to AB 2011 (Wicks) Affordable Housing and High Road Jobs Act of 2022

Councilmember Albin-Smith asked for a further explanation of the Council Letter opposing AB 2011. City Manager Spaur explained that the League of California Cities had sent all city governments information on this proposed legislation, urging them to oppose the bill as it disregards state-mandated local planning efforts and would not allow local government decision-making and community involvement in the housing planning and approval process. Mr. Spaur noted that many of the items included in the bill are favorable, but many things need to be revised and the bill goes too far.

7. PUBLIC HEARING

7A. 22-231 Conduct Public Hearing, Receive Report and Consider Adoption of City Council Resolution Adopting Mitigated Negative Declaration and Mitigation Monitoring Plan for the Raw Water Line Replacement Project, City Project 2019-02

Mayor Norvell opened the public hearing at 6:30 PM.

Assistant City Engineer O'Connor presented the staff report on this agenda item. Public Comment was received from:

• Jacob Patterson spoke about analysis of the impacts to cypress trees and mitigation measures. He stated the City's response does not adequately respond to the California Department of Fish and Wildlife's (CDFW) recommendations and needs to be fixed.

Mayor Norvell closed the public hearing at 6:38 PM.

<u>Discussion</u>: Christa Redd, the consultant who prepared the report, noted that they have been working hand-in-hand with CDFW as the City obtains permits from them. Some of their

suggestions have already been completed; others the City is working toward.

Mayor Norvell re-opened the continued public hearing at 6:46 PM.

Consultant Marie Jones of Marie Jones Consulting presented the report on this agenda item. <u>Public Comment</u> was received from:

- Jacob Patterson said there should be separate resolutions for the CEQA document and the ordinance and recommended that two words from the definition for accessory uses be removed.
- Brandy Moulton spoke about cannabis wholesale and distribution, recommending that the City align the manufacturing definition with the state's definition. She noted that all other cities and the County of Mendocino have successful cannabis ordinances, and Fort Bragg is the last to adopt one.
- Shelley Green said the City should promote environmental, nature, and blue economy tourism, not cannabis tourism.

Mayor Norvell closed the public hearing at 7:08 PM.

<u>Discussion</u>: Councilmembers discussed the minor use permit process. It was the majority opinion that the ordinance be amended by adding "dry sifters, "vibrating screens," and "rosin presses" to the Craft Cannabis Manufacturing definition.
