District Administrator Keyes reported on the highlights of the FY 2016/17 proposed C.V. Starr Community Center (CVSCC) budget.

- ❖ Silver Sneakers Program has increased; revenue is up
- ❖ Rentals are up
- ❖ Mendocino Sports Club members transferring to CVSCC and encouraging others
- ❖ Energy rebates received
- ❖ Propane and electricity costs are down because of efficiency measures
- ❖ Improvements to dog park caused maintenance costs to go slightly over budget for last year
- ❖ Plan to track the equipment/assets recommended
- ❖ Mid-year discussion re capital improvement projects planned
- ❖ Capital repair and equipment reserve fund for Floor Drains - \$110K

An increase in the maintenance budget was discussed. It was generally agreed that fees should not be changed at the present time. Tax revenue projections were discussed.

The budget will be presented to City Council at the June 27, 2016 meeting for approval.
