AGENDA ITEM SUMMARY

TITLE:

Receive Report and Consider Adoption of City Council Resolution Authorizing the City Manager to Execute Local Government Emergency Shelter Certification for Mendocino Coast Hospitality Center Emergency Solutions Grant (ESG) Submittal

ISSUE:

The Mendocino Coast Hospitality Center has requested that the City complete an Emergency Shelter Certification of Local Government Approval as part of its required grant application for a State Emergency Solutions Grant (ESG). This funding is ongoing and is applied to the operations of the Hospitality House.

The State of California Department of Housing and Community Development (HCD) administer the Emergency Solutions Grants program with funding received from the U.S. Department of Housing and Urban Development (HUD). HCD utilizes the established Continuum of Care Areas for distribution and allocation of funding. The Mendocino County Homeless Services Continuum of Care (CoC) serves as the local conduit for these funds. The ESG program provides grant funding to (1) engage homeless individuals and families living on the street, (2) rapidly re-house homeless individuals and families, (3) help operate and provide essential services in emergency shelters for homeless individuals and families, and (4) prevent individuals and families from becoming homeless.
