*TIME ALLOTMENT FOR PUBLIC COMMENT ON NON-AGENDA ITEMS: Thirty (30) minutes shall be allotted to receiving public comments. If necessary, the Mayor or Acting Mayor may allot an additional 30 minutes to public comments after Conduct of Business to allow those who have not yet spoken to do so. Any citizen, after being recognized by the Mayor or Acting Mayor, may speak on any topic that may be a proper subject for discussion before the City Council for such period of time as the Mayor or Acting Mayor may determine is appropriate under the circumstances of the particular meeting, including number of persons wishing to speak or the complexity of a particular topic. Time limitations shall be set without regard to a speaker's point of view or the content of the speech, as long as the speaker's comments are not disruptive of the meeting.*

*BROWN ACT REQUIREMENTS: The Brown Act does not allow action or discussion on items not on the agenda (subject to narrow exceptions). This will limit the Council's response to questions and requests made during this comment period.*

*WRITTEN PUBLIC COMMENTS: Written public comments received after agenda publication are forwarded to the Councilmembers as soon as possible after receipt and are available for inspection at City Hall, 416 N. Franklin Street, Fort Bragg, during normal business hours. All comments will become a permanent part of the agenda packet on the day after the meeting or as soon thereafter as possible, except comments that are in an unrecognized file type or too large to be uploaded to the City's agenda software application. City Council,

I see you are having another closed session about the defective paving work at the Intersection of Oak and Harold Streets. You really should be having closed sessions about the paving project in general, not just at this intersection. We are nearly at the one year mark since the paving work was performed and it only has a 12-month warranty period, which the contractor refused to extend when we requested it. I assume we need to request warranty repairs prior to initiating litigation (although maybe not) and I don't want us to neglect to enforce our rights in a timely manner to address the deficient paving work done to Franklin Street, which is far more extensive and significant than the slope issue at Oak and Harold. We have waited too long in the past to submit warranty claims for defective equipment (e.g., the electronic notice board we installed at and later, thankfully, removed from City Hall) and it would be terrible if we drug our feet and left ourselves on the hook for the cost of the repairs to Franklin. Please be sure to meet all procedural deadlines.

Also, as I noted in my comment for 8D in the regular meeting, the people responsible for this paving work not meeting requirements are being recommended for the next paving project too. That is questionable, at best. We are having to spend a bunch of money on legal action because of the work performed by these contractors yet we are thinking about awarding them more similar work? What?
