





What does the Entertainment Zone mean for the public?

- Per FBMC 05.06.010, the purpose of Entertainment Zones is to promote economic development, enhance community events, and allow the regulated consumption of alcoholic beverages in designated public areas during approved special events.
- All ages are welcome in the Entertainment Zone (excluding businesses that have existing age restrictions)
- Attendees that have verified 21+ status will receive a wristband at the first licensed premise they patronize
- At participating licensed premises, wristbanded attendees may purchase alcoholic beverages in to-go cups, branded with a unique "EZ Sip" sticker. Beverages may be consumed within the EZ boundaries and at stores that do not sell alcohol (subject to each store's preference).
- Beverages must be consumed or discarded prior to leaving EZ boundaries and/or prior to entering another licensed alcohol establishment.
- After 9:00, the Entertainment Zone is over, and the area returns to standard alcohol regulations
- Alcoholic beverages may not be:
 - Brought from home and consumed within the Entertainment Zone
 - Delivered from a third party to the Entertainment Zone
 - Purchased from Off-Sale establishment and consumed in the Entertainment Zone
