RESOLUTION OF THE FORT BRAGG CITY COUNCIL APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH CRAWFORD & ASSOCIATES INC. FOR ENGINEERING AND DESIGN SERVICES FOR THE SOUTH FORT BRAGG COASTAL TRAIL (AMOUNT NOT TO EXCEED: \$81,002; ACCOUNT NO. 415-5012-0310) AND AUTHORIZING CITY MANAGER TO EXECUTE SAME, AND APPROVING BUDGET ADJUSTMENT NO. 2015-17 AMENDING THE FY 2014/15 BUDGET TO APPROPRIATE PROPOSITION 84 FUNDS (FUND 149) IN THE AMOUNT OF \$95,947TO ACCOUNT NO. 415-5012-0310

WHEREAS, the City and Georgia-Pacific are negotiating a transfer of property to allow for public access to the South Coastal Trail property through the Cypress Street intersection; and

WHEREAS, funds from the Prop 84 grant for the Fort Bragg Coastal Trail may be used for design and engineering services in order to augment the design so that it includes a multiuse trail along the southern edge of the access road, and various improvements to the entire access so that all vehicles to the Coastal Trail, Wastewater Treatment Facilitiy and Noyo Center can safely utilize the access; and

WHEREAS, based on all the evidence presented, the City Council finds as follows:

- 1. Cathy McKeon, currently of Crawford & Associates Inc. has served as the engineer of record for this project since design and engineering started on the project in April 2009.
- 2. Approving the contract will enable the City to design and engineer a consolidated access road and multi-use trail to the Coastal Trail, WWTF and Noyo Center property.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Fort Bragg does hereby approve a Professional Services Agreement with Crawford & Associates Inc. for the Engineering of the Modifications to the Fort Bragg Coastal Trail Project (Amount not to Exceed: \$95,947 (Account Number 415-5012-0310) and authorizes City Manager to execute same; and

BE IT FURTHER RESOLVED that the City Council of the City of Fort Bragg does hereby authorize a budget adjustment to allocate \$95,947 from the Proposition 84 funds (Fund 149) to Account No. 415-5012-0310.
