

SECOND AMENDMENT
AGREEMENT WITH PACIFIC LEGACY, INC.
FOR AN ETHNOGRAPHIC STUDY AND IMPLEMENTATION OF AN ARCHAEOLOGICAL
DATA COLLECTION PLAN FOR THE FORT BRAGG COASTAL RESTORATION AND
TRAIL PROJECT

THIS FIRST AMENDMENT is made and entered into this ____ day of May, 2015, by and between the CITY OF FORT BRAGG, hereinafter referred to as "CITY", and Pacific Legacy, Inc., hereinafter referred to as "CONSULTANT".

WHEREAS, CITY contracted with CONSULTANT to prepare an extended ethnographic study and implement an archaeological data collection plan for the Fort Bragg Coastal Restoration and Trail Project; and

WHEREAS, CITY requires additional services to provide for an extended Phase I archaeological survey for compliance with Mitigation Measure 2 of the Final Subsequent EIR for the Fort Bragg Coastal Trail Phase II Project; and

WHEREAS, the CITY and CONSULTANT agree it is in their best interests to extend the project completion date and include these changes in the design work CONSULTANT is preparing for the Coastal Restoration and Trail Project.

WHEREAS, CONSULTANT is best able to provide additional services as they are familiar with the project.

NOW, THEREFORE, for the aforementioned reasons and other valuable consideration, the receipt and sufficiency of which is acknowledged, City and Consultant hereby agree that the Professional Services Agreement for Ethnographic Study and Implementation of an Archaeological Data Collection Plan for the Fort Bragg Coastal Restoration and Trail Project between the CITY and CONSULTANT dated March 10, 2014, as amended by the First Amendment dated August 11, 2014, is hereby amended as follows:

1. **SCOPE OF WORK:**

The Scope of Work is hereby amended to add additional services to provide for an extended Phase I archaeological survey for compliance with Mitigation Measure 2 of the Final Subsequent EIR for the Fort Bragg Coastal Trail Phase II Project.

2. **PAYMENT TERMS:**

The Not to Exceed amount is hereby increased from \$149,570.30 to **\$180,394.68** (an increase of \$30,816.38) to reflect the extended archaeological survey.

3. **TERM and TIME OF COMPLETION:**

The term and time of completion is hereby amended to **December 31, 2015**.

3. Except as expressly amended herein, the Professional Services Agreement, between the CITY and CONSULTANT dated March 10, 2014, as amended by the First Amendment dated August 11, 2014, is hereby reaffirmed.
