### **A RESOLUTION OF THE CITY COUNCIL OF FORT BRAGG RECONFIRMING ITS ELECTION TO BECOME SUBJECT TO THE UNIFORM CONSTRUCTION COST ACCOUNTING PROCEDURES SET FORTH IN ARTICLE 2 OF THE CALIFORNIA PUBLIC CONTRACT CODE**

**WHEREAS**, on April 13, 1987 by Resolution 1497-87 the City Council of the City of Fort Bragg elected to become subject to the uniform public construction accounting procedures under Public Contract Code Section 22000, et seq. ("Uniform Public Construction Cost Accounting Act"); and

**WHEREAS**, in June 2007 pursuant to Ordinance \_\_\_\_-\_\_\_\_, the City Council repealed the City's informal bidding procedures as part of a general update of the City Municipal Code; and

**WHEREAS**, the City Council is considering an amendment to the City's purchasing ordinance that includes informal bidding procedures; and

**WHEREAS**, pursuant to Public Contract Code Section 22030, the City's authority to adopt informal bidding procedures requires its governing body to first elect to become subject to the cost accounting procedures set forth in the Uniform Public Construction Cost Accounting Act; and

**WHEREAS**, the City Council wishes to affirm, and reaffirm, its election to become subject to the uniform public construction accounting procedures under the Uniform Public Construction Cost Accounting Act;

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Fort Bragg does hereby elect to become subject to the uniform public construction cost accounting procedures set forth in the Uniform Public Construction Cost Accounting Act and to the Commission's policies and procedures set forth in the Act and as promulgated by the Uniform Construction Cost Accounting Commission, as they may each be amended from time to time") and

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that the City Council of the City of Fort Bragg hereby directs the City Clerk to notify the State Controller of the City's decision to affirm, and reaffirm, such election as required by Section 22030 of the Public Contract Code.
