AGENDA ITEM TITLE:	Continue Discussion Regarding Purchasing Ordinance, Informal Bidding Procedures Ordinance, and Resolution Reconfirming Election to Become Subject to the Uniform Construction Cost Accounting Procedures and Make Recommendation to Council

ISSUE:

On October 2, 2013 and again on November 6, 2013, City staff presented a detailed report to the Finance & Administration Committee regarding proposed updates to Fort Bragg Municipal Code (FBMC) Chapter 3.20, which governs purchasing, procurement and leasing of supplies, equipment, and services. The updates include a procedure to allow informal bidding procedures in certain circumstances, consistent with the Uniform Public Construction Cost Accounting Act. This item was brought back to the Finance & Administration Committee at a special meeting on June 23, 2015 for further discussion and continued to the June 29, 2015 regular meeting.

SUMMARY:

At the June 23, 2015 meeting, the Committee recommended changes to the draft purchasing ordinance as follows:

- Cap the purchasing authority of the City Manager at \$25,000.
- Limit the positions to which the City Manager can delegate authority to sign contracts.
- Provide clarification of what it means for a contract to be "budgeted."
