RESOLUTION OF THE FORT BRAGG CITY COUNCIL APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH WEST ENTERPRISE CENTER, INC. (DBA: WEST COMPANY) FOR COMMUNITY DEVELOPMENT BLOCK GRANT FUNDED MICROENTERPRISE ASSISTANCE PROGRAM OPERATION AND AUTHORIZING CITY MANAGER TO EXECUTE SAME (AMOUNT NOT TO EXCEED \$232,558; ACCOUNT NO. 315-5020-0630)

WHEREAS, the City was awarded a grant from the 2014 State Community Development Block Grant program for Microenterprise Assistance activities; and

WHEREAS, Program Operation tasks include provision of Microenterprise Technical Assistance, Support Services, and Financial Assistance activities for qualifying low- and moderate-income micro-entrepreneurs who reside in or currently operate or plan to operate a business in Fort Bragg City limits; and

WHEREAS, a Request for Proposals was released and broadly advertised on June 18, 2015, and responses were due on August 12, 2015; and

WHEREAS, the single proposal received was from West Enterprise Center, Inc. (DBA West Company); and

WHEREAS, on September 15, 2015, the City was notified that the State Department of Housing and Community Development authorized a Non-Competitive Proposal/sole source procurement process for award of the Microenterprise Assistance contract to West Enterprises, Inc.; and

WHEREAS, the Program is subject to the National Environmental Policy Act (NEPA) and is exempt pursuant to the Code of Federal Regulations, Title 24 Housing and Urban Development – Subpart D: Environmental Review Process, Section 58.34 – Exempt Activities (24 CFR 58.35(b)); and

WHEREAS, funds in the amount of \$232,559 have been appropriated in the FY 2016/2016 budget for this activity and sufficient funds are available for this contract; and

WHEREAS, based on all the evidence presented, the City Council finds as follows:

- 1. The City applied for and received grant funding for microenterprise assistance activities that is sufficient to pay for the contract.
- 2. After issuing a Request for Proposals and considering the qualifications of the sole respondent, West Enterprise Center, Inc. was found to be capable to perform the required tasks.
- Authorization has been requested and received from the State Department of Housing and Community Development for a Non-Competitive Proposal/sole source procurement process.

4.	Securing services from West Enterprise Center, Inc. will ensure provision of services for
