the upcoming year, services will likely focus on the Operable Units C, D, and E, including Feasibility Studies, Remedial Action Plans, remedial design, and various stakeholder meetings to assist the Agency with maintaining it's Polanco Act immunity rights. TRC's actual scope of work is subject to the directions provided by the Agency as well as the owner's actual activities and the project schedule. Accordingly, TRC has prepared this proposal assuming a certain level of effort for anticipated services over the course of the next year, through June 3130, 2016.

FEES AND TERMS
