## RE: Active Trails Program (ATP) Grant Application for the Rehabilitation of the MacKerricher Haul Road

To Whom It May Concern:
The Fort Bragg City Council enthusiastically supports the Active Trails Program (ATP) grant application for the rehabilitation of the MacKerricher Haul Road between the Pudding Creek Trestle and Ward Avenue, within MacKerricher State Park in Fort Bragg.

As you know, the Mendocino Coast is known for its stunning coastal vistas. The MacKerricher Haul Road offers spectacular views of the ocean and recreational opportunities to residents, commuters and hundreds of thousands of tourists each year. It is heavily used by bicyclists, hikers, walkers, joggers and equestrians.

Additionally this trail connects with the Pudding Creek Trestle and the new Fort Bragg Coastal Trail. Once the middle section of the Coastal Trail is completed, the two trail systems will provide 11.2 miles of coastal multi-use trails and form a segment of the Pacific Bikeway. There is an overwhelming need to provide an alternate route for bicycles and pedestrians through the narrow stretch of Highway One from Cleone to the Fort Bragg city limits. This much needed project will help move pedestrian and bicycle traffic off of the Highway One corridor.

Due to constant use, coastal conditions and State Parks budgetary issues, the MacKerricher Haul Road has seriously deteriorated over the years rendering it difficult for some uses and in places, it is not ADA accessible. Maintaining the recreational trail is a high priority for the community as it is an important tourism attraction in our tourism dependent economy.
