Mayor Peters called the meeting to order at 6:03 PM.

AGENDA REVIEW

Mayor Peters moved Item 7B. to the last matter on the Conduct of Business agenda.

1. MAYOR'S RECOGNITIONS AND ANNOUNCEMENTS

1A. <u>17-275</u> Presentation of Proclamation Commending the Fort Bragg Fire Department for Response to Structure Fire at 542 North Main Street

Mayor Peters presented Fort Bragg Fire Chief Steve Orsi with a proclamation commending the Fire Department for responding to a structure fire at 542 N. Main Street. Chief Orsi and Darrell Orsi gave credit to the hardworking volunteer firefighters.

1B. <u>17-278</u> Presentation on the Blue Zone Project by Nutrition Educator Petra Schulte

Nutrition educator Petra Schulte presented information to the Council on the Blue Zone Project for increased health and longevity.

2A. PUBLIC COMMENTS ON NON-AGENDA, CONSENT CALENDAR & CLOSED SESSION ITEMS (30 Minutes)

- James Goekler, lead treatment operator, spoke in support of having an attractive employment package for new and continuing employees.
- Ann Rennacker reported that the Library Advisory Board will have a fundraising event on September 1 in support of their explansion plans.
- John Gallo spoke about monetizing the open space on the former Georgia-Pacific mill site.

3. STAFF COMMENTS

Police Chief Lizarraga reported that the Day in the Park event last weekend was very successful,

drawing an estimated 400 people. He noted that Fire & Safety Day at the high school will be this Friday. City Manager Ruffing announced that the budget workshop will be at 9AM on May 24 at Town Hall.

4. MATTERS FROM COUNCILMEMBERS

Mayor Peters commented on Day in the Park and reported on the Public Safety Committee meeting and the League of California Cities Redwood division conference last week. He noted that Georgia-Pacific is planning to demolish Dry Shed #4, which is scheduled for a hearing before the Planning Commission in June. Vice Mayor Lee reported on the League of California Cities meeting which focused on housing shortages and noted that the Council is dedicated to expanding affordable housing in the community. Councilmember Cimolino reported on Safe Rx program and a Police Department procedure for administering antidotes to persons who have overdosed on drugs. He requested an update on the Hare Creek Center project. Councilmember Turner reported on the Adopt-a-Fifth-Grader event, stating that the number of children "adopted" is 30 this year, up from 5 last year.

6A. <u>17-269</u> Conduct Public Hearing, Receive Planning Commission

Recommendation, Consider Adoption of a City Council Resolution Adopting a Negative Declaration, Waive the First Reading, and Introduce by Title Only Ordinance 930-2017 Amending Fort Bragg Municipal Code Title 18 (Inland Land Use and Development Code)

Associate Planner Perkins presented the staff report on this agenda item and covered the most significant changes to the Inland Land Use and Development Code (ILUDC). He responded to questions concerning definitions of terms, water availability, neon signs, agriculture product processing, libraries, museums and open space. Planner Perkins reminded Council that they would be taking two actions: (1) Adopt the Negative Declaration; and (2) Introduce the Ordinance by title only, waiving the first reading.

Mayor Peters opened the public hearing at 7:04 PM; seeing no one who wished to speak, he immediately thereafter closed the public hearing.

Discussion items included:

- Enforcing ordinances regarding littering and smoking near business entrances.
- Informing the public about the stewardship program through press releases, publicity and social media posts.
- Changes to the street sweeping grid to allow more effective street cleaning.

The Council approved of the slogan, the receptacle program and the Terracycle recycling efforts.

7C. <u>17-284</u> Receive Recommendation from Finance & Administration Committee Regarding Storm Drainage Fees and Provide Direction to Staff

City Manager Ruffing presented the staff report on this agenda item regarding changing the methodology of calculation of the storm drainage fees.

• Eric Dwyer spoke in opposition to bringing the PEG administration in-house at the City and

requested that an RFP be issued for these services.

- Ann Rennacker stated she would like to see more educational programs included on the PEG channel.
- Terry Vaughn suggested a citizen's oversight committee to regulate the PEG.

 <u>Discussion:</u> The Council generally agreed that staff should look into organizing a citizen's oversight committee and to have the PEG Ad Hoc Committee review the matter in July. Council directed staff to proceed with taking PEG in-house and have the part-time A/V Technician begin full time starting on July 1.

Staff was directed to schedule a meeting of the PEG Ad Hoc Committee to discuss organization of a citizen's oversight committee. Council approved taking PEG in-house and changing the A/V Technician from part-time to full-time beginning July 1.
