

MEASUREMENT AND PAYMENT

PART 1 GENERAL

1.1 SUMMARY

- A. Payment for the various items of the Bid Schedule, as further specified herein, shall be the sole compensation to be received by the Contractor for furnishing all tools, equipment, supplies, manufactured articles, professional services, labor, operations, and incidentals appurtenant to the items of work being described as required to complete the Work in accordance with the requirements of the Contract Documents.
- B. Said compensation shall also include all costs of compliance with the regulations of public agencies having jurisdiction, including, but not limited to, safety and health requirements of the California Department of Industrial Relations, the Occupational Safety and Health Administration of the U.S. Department of Labor (OSHA), the requirements of the California Department of Public Health, Drinking Water Office, and the requirements of the California Regional Water Quality Control Board.
- C. No separate payment will be made for any item that is not specifically set forth in the Bid Schedule, and all prices placed therein by the Contractor shall include all costs for the various items of the Work.

1.2 MEASUREMENT

Materials and unit price items of Work that are to be paid on the basis of measurement shall be measured in accordance with the following subsections of this specification.

- A. Measurement by Volume: Measured by cubic dimension using mean length, width, and height or thickness.
- B. Measurement by Area: Measured by square dimensions using mean length and width, or radius.
- C. Measurement by Weight: Measured by the pound of steel reinforcement using mean length and weight per lineal foot, for each diameter of reinforcement.
- D. Linear quantities of pipe shall be considered as being the true length measured along the longitudinal axis of the pipe.
- E. Engineer will make measurements and compute quantities accordingly. The Contractor shall assist in taking of measurements.
- F. Quantities and measurements indicated in the Bid Schedule are for contract purposes only. Quantities and measurements supplied or placed in the Work shall determine payment.
 - 1. When actual work requires more or fewer quantities than those indicated, the Contractor shall provide the required quantities at unit prices contracted.
 - 2. When actual work requires 25 percent or greater change in quantity than those quantities indicated, Owner or Contractor may claim for Contract Price adjustment.

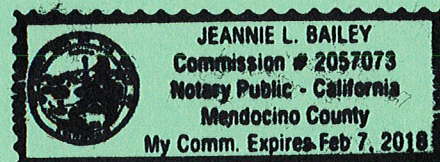

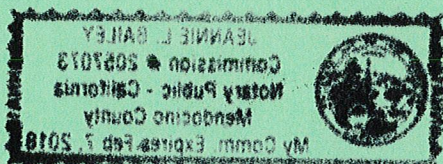
