# 3. CONDUCT OF BUSINESS

**3A1** <u>18-270</u> Status update of waste water treatment facility upgrade project

Director Varga gave a brief overview of staff report.

Items of discussion:

-Possible appeal of Coastal Development Permit by Jacob Patterson.

**3A2** 18-271 Weed Abatement Plan Update

Director Varga gave a brief overview of staff report.

# Items of discussion:

- -Franklin from Pine to Oak and Main from Elm to Noyo Bridge are the "priority areas" for weed management.
- -Maintenance agreement with Caltrans covers litter and debris removal by the City (which presumably includes weeds) along Main Street (Highway 1).
- -Maple Street and CV Starr Center need to be "priority" as well. There have been complaints.
- -Sidewalk, curb, and gutter are the responsibility of the property owner.
- -Letters going to property owners that have weed issues, as well as content of letters.

3A3 <u>18-274</u> Receive Oral Update from Staff on Departmental Activities

Water Tank Project: Tank is done, minor adjustments to be made as well as site cleanup.

Relocation of Water Main at GP Dam: Working with CalOES regarding funding.

Glass Beach Stairs: Looking at alternates. Geologist is lined up.

Working on submittal of SB1 dollars with CTC and MCOG.

CDD Director Jones stated Parents and Friends Project was approved for \$3M with CDBG dollars.

4 units of housing, 4 people in each unit.

Future project needs.

#### 4. MATTERS FROM COMMITTEE / STAFF

#### Items of Discussion:

- -Parking in the downtown business district and painting lines on the street as "guides." Possibility of Parking Meters, Kiosks and permits. Speak to parking enforcement officer regarding parking per request of Committee Member Lee. Director Varga to research and come back with data and cost/benefit analysis for the Committee.
- -Street sweeping did not happen by middle school this month because of Independence Day setup. Will happen again in August. Possibility of doing one side of the street or other.
- -People spinning donuts in back of CV Starr Center with vehicles in dirt area is becoming a problem. There have been complaints.

#### **Public Comment:**

- -Rex Gressett: 7% of CDBG grant money is "for City." It covers administration cost. If Skunk Train grant is approved, additional full time person.
- -Citizen: Glass Beach stairs alternatives would be great. Construction at beginning of next season would be suggested.
