Thank you Chantell for sending this agenda to me. I will not be able to attend the Town Hall meeting on the 19th as I have a doctor's appointment in Ukiah on that afternoon. Would you be so kind as to have my note read at the meeting in my absence? The note is as follows:

To the City of Fort Bragg,

Alger Street is not your average dead-end street as our street has a lot of activities and traffic on it, both up and down the street. There are 3 residences which are homes for 13 people, all who own vehicles. Then there is the Pacific Textiles, the Woodworking School and the school bus barns who all create a great deal of wear and tear on the street with many trips back and forth on the road, especially heavy buses. Then there are the Little League and soccer leagues who use the Middle School field for their practices and games and all the traffic that those activities create.

Our street has been in need of a total rejuvenation for a long time. After a lot of complaining we did get some of the potholes filled, but besides potholes and uneven pavement, there is a lack of lines to indicate it is even a street. Because the bus barns and the woodworking school have large parking lots that abut the street without any additional marking where the street stops and the parking lots begin, it is dangerous for children darting in and out of the playing field. And some of their parents either partially or fully park on the street, making it difficult to pass at times. If the street had broken lines painted down the middle and possibly a line indicating the east and west edges of the street, people would know that Alger is actually a real street, not just a continuation of parking lots.

Also, there is a fire hydrant on the west side of the street which is marked with two signs as no parking, but I see people parked right in front of it all the time. If there was some kind of barrier put up to deter parking, but still allowing access to the Fire Department, it would remain accessible in case of a fire anywhere along the street. If a barrier is not possible, maybe a parking officer making more frequent monitoring, especially in the afternoons and evenings when games or practice is going on, would keep our street safer.

I would propose that if you did a traffic study on our street on all days of the week, and all daylight hours of the day, you would find that our street gets more traffic than most regular open-end streets throughout town.

Please consider Alger Street a priority the next time you do street repair to address some or all of these issues.
