Hello again Chantell,

I forgot to mention in my email to you that we have a section of the street where no parking is allowed on the west side of the street and it is clearly marked with signs, but people often ignore the signs and park there anywhere, which makes it difficult to get out of driveways and turn your car south to exit the street and it also impedes emergency vehicles. A simple solution would be to add red paint to the curbs along that section of the street which is only about 75 to 100 feet long. We think that would further deter people from parking along this section.
