
Public Records Request Platform

City Council Meeting November 26, 2018

California Public Records Act (PRA) Government Code §§ 6250-6276.48

- Give the public access to information so that they can monitor the actions of their government
- Presumption that records will be made available to the public, unless there
 is a legal reason not to do so
- What is considered a public record is broadly defined
- Legal exceptions are limited
- Very limited applicability of fees to offset the costs of producing records

City of Fort Bragg Public Records Requests



Impact to City of Fort Bragg

- Increased volume and complexity
- Estimated annual staff cost of \$66,723 or 878 staff hours
- 25% of the City Clerk's time
- Lost opportunity cost to work on other projects or tasks

Managing the Increase in PRA Requests

- Allocate set amount of staff time to requests to better manage time
- More efficiently respond to Requests
- NextRequest web-based platform
 - Automates many of the steps
 - Tracks staff time, cost spent and requestor
 - Read receipts
 - Self-service
 - Publicly available
 - Proactively post documents
