AGENDA ITEM SUMMARY

TITLE:

Approval of Councilmember Albin-Smith's Nomination of Michelle Roberts, Approval of Councilmember Morsell-Haye's Nomination of Jeremy Logan, Approval of Mayor Lee's Nomination of Jay Andreis and Confirmation of Councilmember Peters' Nomination and Continued Appointment of Stan Miklose to Serve on the Fort Bragg Planning Commission

ISSUE:

Pursuant to the Fort Bragg Municipal Code (FBMC), each Councilmember nominates one registered City voter for appointment to the Planning Commission (FBMC §§ 2.20.020 and 2.20.030). Planning Commissioner terms coincide with the term of the nominating City Councilmember. Once nominated, the City Council votes on the appointment of the nominee. A nominated Commissioner must receive at least three (3) affirmative votes to be appointed.

Nominations:

- 1. Councilmember Albin-Smith nominates Michelle Roberts
- 2. Councilmember Morsell-Haye nominates Jeremy Logan
- 3. Mayor Lee nominates Jay Andreis
- 4. Councilmember Peters nominates Stan Miklose for continued appointment

ANALYSIS:

The Planning Commission reviews land use and development permits (use permits, coastal development permits, design review permits, subdivisions, etc.) for consistency with the goals and policies of the Fort Bragg General Plan, and the development standards of the Fort Bragg Municipal Code. All Planning Commission decisions may be appealed to the City Council. The Planning Commission provides recommendations to the City Council on General Plan amendments and rezoning requests, and provides direction to the Community Development Department regarding the interpretation of City planning policies and codes.

Once appointed, the Commissioners select a Chair and a Vice Chair, amongst themselves. The Planning Commission is an advisory body to the City Council and serves at the will of the City Council. The City Council may remove any Planning Commissioner at any time through an affirmative vote of at least four (4) of the City Councilmembers (FBMC § 2.20.020).

RECOMMENDED ACTION:

Approve by a roll call vote each Councilmembers' nominations for Planning Commission.

ALTERNATIVE ACTION(S):

1. Vote to not approve any or all of the Councilmembers' nominations for Planning Commission.
