Specific Actions for Town and County Governments Marin County and General Guidelines from Climate Reality Project

The Marin County Board of Supervisors has taken several actions. These can be verified on the County's website. They include:

- 1. Initiating a County Climate Action Planning process and adoption of a CAP in about 2003
- 2. Assisted with the creation of the Marin Energy Authority, which launched in 2010, and is now "MCE Clean Energy", the initial Community Choice Aggregation entity that is a Joint Powers Authority.
- 3. On Nov 10, 2015, passed a Climate Resolution for delivery to the U.N.'s COP-21 in Paris (attached)
- 4. In May, 2016, passed a Resolution supporting Congressional Action on a Carbon Fee & Dividend
- 5. Assisting with State Legislature Resolution AJR 43 with similar content (attached)
- 6. A Resolution in Oct. 2017 initiating a County-wide campaign to reduce Carbon Emissions (attached)
- 7. Launching on Oct 3rd, 2017 a "Drawdown: Marin" campaign (See: www.drawdownmarin.org)
- 8. Hiring a Senior Program Manager to coordinate the Drawdown: Marin campaign
- 9. Commencing the working groups and Steering Committee to guide the Drawdown campaign. (See website)
