("Agreement") for the Caspar Transfer Station, and Agreement was approved by the Board of Supervisors with the consent and concurrence of the City of Fort Bragg on January 28, 2011 (BOS Agreement #11-008); and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. <u>11-008</u>, from <u>June 30</u>, <u>2017</u> to <u>June 30</u>, <u>2021</u>; and

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. <u>11-008</u> will be extended from June 30, 2017 to June 30, 2021.
