5. CONDUCT OF BUSINESS

5A. 19-302

Receive Recommendation from the Planning Commission and Provide Direction Regarding Mill Site Reuse Plan Local Coastal Program (LCP) Amendment Including: 1) Recommended Policy Changes from the Mill Site Utility Study; 2) Recommended Revision of the Land Use Plan; and 3) Recommended Use Tables and Development Standards for each Proposed Land Use

Chair Rogers wanted to clarify if item 3) Recommended Use Tables and Development Standards for Each Proposed Land Use is informational only and staff is not seeking direction on this item. Director Jones confirmed that this is information that was previously requested by the Planning Commission for comparison.

Public Comment:

- * Amy Wynn states she like the map zoning as is and discourages making zoning too restrictive and thinks that regulations will take care of a lot of development concerns.
- * Jacob Patterson states that he likes the fixing of the street grids on Commissioner Andreis and Director Jones's maps, and states that in general he likes a lot of the changes reflected on the maps.
- * Jennifer Bosma states she appriciates all the maps and particulary likes Commissioner Andreis map, she states that she feels like the maps would allow to add housing and jobs on the Millsite.

Further Disscussion:

Commissioners ask claiflying questions and Director Jones took recommendations on zoning changes and updated the maps accordingly. Director Jones states that she will combine the ideas of the four Commissioners on to a new map to present to City Council at the special saturday meeting.

Chair Rogers inquired on the Farmers Market table and how that is going. Assistant Planner McCormick states that each department will take a turn running the table.

Commissioner Miklose inquired on the status of the borings and the code enforcement at the shop. Director Jones and Assistant Planner McCormick state that Code Enforcement is in progress and that the borings permit was approved.

Director Jones states that DTSC has sent a letter to Georgia Pacific and that the City is in receipt of a copy of the letter.
