- (1) APPROVING AN AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF FORT BRAGG AND JONES & MAYER FOR THE PROVISION OF LEGAL SERVICES AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAME; AND (2) APPOINTING SCOTT PORTER TO SERVE AS ASSISTANT CITY ATTORNEY, ASSISTANT DISTRICT GENERAL COUNSEL AND ASSISTANT AGENCY GENERAL COUNSEL
- WHEREAS, the City of Fort Bragg ("City") entered into a Retainer Agreement for City Attorney Services with the Law Offices of Jones & Mayer ("Jones & Mayer") on July 8, 2019 pursuant to Resolution 4166-2019, Resolution ID 413-2019, and Resolution RS 21-2019; and
- **WHEREAS**, the City and Jones & Mayer desire to modify the terms of the agreement to designate and appoint Scott Porter as the Assistant City Attorney, Assistant District General Counsel and Assistant Agency General Council in the place and stead of Ryan R. Jones; and
- **WHEREAS**, based on Mr. Porter's experience and expertise in general municipal law matters, the Council finds that Mr. Porter is well-qualified to serve as Assistant City Attorney, Assistant District General Counsel; and Assistant Agency General Counsel; and
- **NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Fort Bragg, the District Board of the Fort Bragg Municipal Improvement District No. 1, and the Agency Board of the Fort Bragg Redevelopment Successor Agency each hereby declare, determine and order as follows:
- **Section 1.** An Amended Retainer Agreement for City Attorney Services, as set forth in Exhibit "A," attached hereto and incorporated herein by reference, is hereby approved and the City Manager is authorized to execute said Agreement on behalf of the City.
- **Section 2.** Scott Porter is hereby appointed to the position of Assistant City Attorney of the City of Fort Bragg, Assistant General Counsel of the Fort Bragg Municipal Improvement District, and Deputy General Counsel of the Fort Bragg Redevelopment Agency, said appointment to become effective upon being sworn in to those positions, and upon being so sworn, Scott Porter shall be empowered to perform the duties of Assistant City Attorney, Assistant District General Counsel and Assistant Agency General Counsel, respectively.
- **Section 3.** The appointment made through, and the authority granted by, this resolution shall include the responsibility and authority to regularly advise the City Council, the District Board, the Agency Board, and their respective staffs and perform various other

duties as needed.

Section 4. Scott Porter shall be bound by the Retainer Agreement for City Attorney Services with the Law Offices of Jones & Mayer, as the same may be amended from time to time.

Section 5. Scott Porter shall comply with City of Fort Bragg Conflict of Interest rules, and the Political Reform Act (Government Code §8100, et seq.) and the FPPC Regulations (2 Cal. Code of Regulations §18109, et seq.).

Section 6. The appointment of Scott Porter as Assistant City Attorney, Assistant District General Counsel, and Assistant Agency General Counsel is not a "project" as that term is defined under the California Environmental Quality Act, and therefore, is not subject to environmental review.
