DRAIN AND ALLEY REHABILITATION PROJECT, CITY PROJECT NO. PWP00116 TO AKEFF CONSTRUCTION SERVICES, INC. AND AUTHORIZING
CITY MANAGER TO EXECUTE CONTRACT (AMOUNT NOT TO EXCEED

WHEREAS, in accordance with California Public Contract Code 20164 and other applicable laws, the Maple Street Storm Drain and Alley Rehab Project, City Project No. PWP-00116 (the "Project") was advertised for bid on February 18, 2021, and February 25, 2021; and

WHEREAS, four (4) bids were received for this Project from the following contractors: Akeff Construction Services, Inc., Argonaut Constructors, Granite Construction Company, Wahlund Construction, Inc.; and

WHEREAS, the lowest bid calculation uses the base bid plus all the alternates total as described in the Notice Inviting Bids; and

WHEREAS, Akeff Construction Services, Inc., is the apparent low bidder and the City has confirmed that Akeff Construction has the proper license, experience and meets the necessary requirements to complete the Project as bid; and

WHEREAS, based on the Project budget and the submittals received, Alternate #1- will be included in the construction contract; and

WHEREAS, the Project is exempt by CEQA section 15301 (C) which allows for repair, maintenance, and/or minor alteration of existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities (this includes road grading for the purpose of public safety). This Project is further exempt by Public Resources Code –PRC 21080 (b) (1) as a Ministerial project proposed to be carried out by a Public Agency; and

WHEREAS, funds in the amount of \$1,750,000 were appropriated in the FY 2020/21 budget for this activity and sufficient funds are available for this contract; and

WHEREAS, based on all the evidence presented, the City Council finds as follows:

- 1. The bid of Akeff Construction meets the requirements of the Project bid documents and is considered responsive.
- Sufficient funds are available to fully complete the Project with the selected alternate.
- 3. Akeff Construction has the proper licenses to complete the Project and based upon previous experience in completing similar projects, is a responsible bidder.
