Mayor Norvell read a Proclamation declaring June 2021 as LGBTQ Pride Month.

3. STAFF COMMENTS

City Manager Miller reported that the Mendocino County Sheriff's Office and Office of Emergency Services will test the Mass Notification Systems on May 26. The City's Independence Day fireworks display will be held on July 3 at nightfall (approximately 9:30 PM). Miller reported that the broadband feasibility study is now underway. The City and County will jointly release a Request for Proposals for a new solid waste franchise agreement in mid-June. Public Works Director Smith noted that this year is shaping up to be the worst drought since 1977. He summarized information regarding the Noyo River flows and said that the voluntary Stage 1 conservation efforts will reduce water consumption by about ten percent.

4. MATTERS FROM COUNCILMEMBERS

Vice Mayor Morsell-Haye reported on a blue economy workshop held last Friday involving several local stakeholders. A symposium open to the public will be held in October. Morsell-Haye reported that the Fort Bragg Name Change Citizens Commission has met twice this month and anticipates presenting recommendations to the Council by November. Councilmember Peters reported that the Fire Protection Authority meets tomorrow regarding budget matters.
