#### **MEETING CALLED TO ORDER**

### 2. PUBLIC COMMENTS ON NON-AGENDA ITEMS

The City of Fort Bragg has emergency plans in place that are determined by the type of emergency and the response needed. A public liaision person will be appointed to keep the community updated which

will be Scott Schneider.

**3C** 17-542 Receive Update on Body-Worn Camera Policy and Demonstration

Chief Lizarraga explained how the cameras operate, that the recordings are subject to the California Public Records Act and the policy that is being fine tuned. Officer Breyer demonstrated the body camera.
