Receive Report and Provide Direction on Mr. Patterson's 45-Day Notice Letter Received April 17, 2018, the California Voting Rights Act of 2001 ("CVRA"), the California Elections Code "Safe-Harbor Provision" Capping Reimbursement of Prospective Plaintiff's Costs to Generate the 45-Day Notice Letter to \$30,000, and Possible Transition from At-Large to District-Based Elections

City Manager Miller presented a slide show regarding the California Voting Rights Act (CVRA) and the demand letter received from a local attorney. She responded to questions regarding hiring a demographer, the burden of proof in CVRA cases, the cost of transitioning to district elections, the \$30,000 to be paid to the attorney, and the possibility of the attorney withdrawing the demand letter. <u>Discussion</u>: After extensive discussion, the City Council directed staff to hire a demographer to prepare a demographic database for the last four City Council elections. The Council directed the ad hoc committee to meet with the local attorney and his committee to discuss the demand letter.

A motion was made by Councilmember Norvell, seconded by Vice Mayor Lee, that the City hire a demographer to conduct a polarization analysis for the four prior City Council elections. The motion carried by the following vote:
