1. MAYOR'S RECOGNITIONS AND ANNOUNCEMENTS

2A. PUBLIC COMMENTS ON: (1) NON-AGENDA, (2) CONSENT CALENDAR & (3) CLOSED SESSION ITEMS (30 Minutes)

- (1) Non-Agenda Items:
- Rella Gadulka invited the public to attend a public forum on Thursday, June 28 at Cotton
 Auditorium from 6:30 to 8:30 PM regarding the Off-Highway Vehicle (OHV) Park proposed by the Mendocino Coast Recreation and Park District.
- Teri Jo Barber reminded everyone that the OHV Park is upstream from the City's water supply and recommended the use of strong buffers for such a project.
- Ann Rennacker reported on a Library Advisory Board meeting set for July in Fort Bragg and the consolidation of libraries, parks and museums into one cultural agency by the Board of Supervisors.
- Barbara Moller spoke in support of putting a Grocery Outlet in the old Social Services Building.
- (2) Consent Calendar Items: None.
- (3) Closed Session Items: None.

3. STAFF COMMENTS

City Manager Miller reported that City Hall and the Police Department will be closed during normal business hours on June 26 for an in-service day. July 2 will be a meeting on the Marbut homelessness report. Community Development Director Jones said Mendocino Council of Governments granted the City \$48,000 to do the transportation study on the Mill Site Plan. The City will have a booth at the Farmers Market on Wednesday afternoons with different staff members available to discuss various City projects and events; this Wednesday will feature Jones talking about the Mill Site. Public Works Director Varga performed an inventory of water lines and acknowledged City staff who checked over 2,900 connections. The new water tank by the City's corp yard is complete, filled with water, and available to be used in the system. The shiny roof on

top of the tank will be mitigated. Varga thanked the City Council for attending the groundbreaking ceremony of the Waste Water Treatment Plant Upgrade Project. Construction has started with site preparation work.

4. MATTERS FROM COUNCILMEMBERS

Mayor Peters reported that there was no reportable action taken at the closed session today. The Mayor appointed a Homeless Action Committee consisting of Councilmember Norvell and City Manager Miller. Mayor Peters will attend a League of California Cities conference this week. One of the sessions is about at-large and by-district elections. The City's demographer is the presenter at the session. Vice Mayor Lee expressed gratitude for the voters passing Measure C to help support the local hospital. Councilmember Norvell reported on the Public Safety Committee meeting, stating that he received 240 signatures and emails from the public suggesting that the Marbut Report be adopted. The Committee also discussed a shopping cart ordinance and taking a more aggressive approach toward panhandling. Councilmember Turner reminded everyone that the Independence Day events are on July 7th this year, including the salmon barbecue and fireworks.

6. PUBLIC HEARING

6A. 18-238

Receive Report, Conduct Public Hearing, Consider Planning Commission Recommendation to Adopt City Council Resolution Adopting a Mitigated Negative Declaration, and Consider Introducing by Title Only and Waiving the First Reading of Ordinance No. 939-2018 Amending Chapter 18.42.040 [Animal Keeping] of Title 18 [Inland Land Use & Development Code] of the Fort Bragg Municipal Code Modifying Beekeeping Permit Requirements to Allow Bee Hives Without a Use Permit in All Zoning Districts

Community Development Director Jones presented the staff report on this item and responded to questions about the one-mile bee hive prohibition from Glass Beach, the issue of food for native bees, and the location of the bees on Glass Beach Headlands.

Mayor Peters opened the public hearing at 6:33 PM.

- Ann Rennacker commended the City Council for being a bee-friendly city and noted that plants that attract pollinators have been planted in the bee garden at the museum. She recommended that Round-Up be banned from sales in the City, as it has negative health aspects.
- Eve Hautala thanked Marie Jones for doing such hard work to put this ordinance together. **Mayor Peters closed the public hearing at 6:35 PM.**

<u>Discussion</u>: After a brief discussion, it was generally agreed to modify the language in Exhibit A of the ordinance to state that bee hives are not permitted within one-half mile of MacKerricher State Park's Glass Beach Headlands, instead of one mile.

Public Comment was received from:

- Simon Smith said this is an excellent example of proactively anticipating what is needed and getting the framework started now. She is in favor of more local control of the Mill Pond.
- Ann Rennacker expressed disappointment with the Department of Toxic Substances Control meeting because they stated dioxins near the dam were not going to be excavated.
- David Jensen thanked Director Jones for the presentation and expressed concern about the level of public participation the process will allow and the amount of time it will take.
- Bob Burns spoke about the cost to Georgia-Pacific of remediating the Mill Pond and perhaps donations could be sought to cover the cost.

<u>Discussion</u>: The Council discussed this item and concurred that the Coastal Development Permit should be processed locally to allow more public input, as community participation is key.

This Staff Report was referred to staff with direction to process the Coastal Development Permit locally, without consolidation with the Coastal Commission.
