# 1. MAYOR'S RECOGNITIONS AND ANNOUNCEMENTS

Mayor Peters read a proclamation recognizing the three participants in the Mendocino Coast Children's Fund's 2018 Bridge Internship Program: Alan Moran, Gabriel Pech and Savhanna Lee VanDeventer.

# 3. STAFF COMMENTS

City Manager Miller announced that the City will have a table at the Farmers Market on Wednesdays with various topics of the week and different staff members available to answer questions. Chief Lizarraga announced that a National Night Out event will be held on August 7, 2018 from 5 to 7 PM at Bainbridge Park. He reported that the County Health Department held a tobacco buy survey on June 28 and of the 14 retailers audited, all but two passed. The Saturday fireworks show was mostly uneventful, with four arrests but nothing extraordinary. The Chief provided statistics on number of people booked, cited and released, and will be giving the Council regular updates on this data. The Neighborhood Watch meeting is the third Tuesday of the month at the Police Department. City Manager Miller reported that she and Councilmember Norvell recently attended a meeting on homeless services, a kickoff to a countywide program to deal with transient and homeless issues in the County. City Clerk Lemos made an announcement that the nomination period for the three at-large City Council seats opens on July 16, 2018, and persons interested in being a candidate for

office should contact her to make an appointment to pull nomination papers.

# 4. MATTERS FROM COUNCILMEMBERS

Mayor Peters attended a League of California Cities conference in Monterey and reported on the California Voting Rights Act (CVRA) district election session he attended. The Mayor noted that a meeting with the Latino Coalition is being scheduled for August 2 to discuss the CVRA and transitioning to district elections. Sonoma Clean Power will hold a meeting on Thursday. The Mayor reported on a minor issue involving trolly service provided by MTA for the Salmon BBQ last Saturday. Councilmember Norvell summarized the cleanup day event for the property on South Street and Cypress. Councilmember Turner spoke about the Salmon BBQ and the City's fireworks event.

## 6. PUBLIC HEARING

6A. 18-182

Receive Report, Conduct **Public Hearing #1** and Consider Adoption of a Resolution Outlining: The City's Intention to Transition from At-Large to District-Based Councilmember Elections; Approving a Tentative Timeline for Conducting Public Hearings; Drafting and Reviewing District Maps and Election Systems; and Presenting an Ordinance to City Council for Decision

City Manager Miller presented the staff report and narrated a slide show on this agenda item. She responded to questions from Councilmembers regarding the potential amount of legal bills involved in transitioning to by-district elections, the implementation of new district elections, the staggering of open seats during election years, recall procedures, the safe harbor provision of the CVRA, and the benefits and drawbacks to fighting the demand letter to convert to district elections. She noted that the demographer's report is still in draft form and has not yet been released.

### Mayor Peters opened the public hearing at 6:50 PM.

- Don Rowe, Mendocino County Coordinator for Californians for Electoral Reform, spoke in support of alternatives to district voting, including changing Fort Bragg from a general law city to a charter city.
- Rex Gressett urged the Council to oppose the transition to district elections and thinks the City should organize with other cities to protect the right to its own self-government.
- Gabriel Quinn Maroney said the claim that the City is in violation of the CVRA has validity and recommends that both sides remain open-minded and move forward with due diligence.
- Jacob Patterson said the Coast Committee for Responsive Representation is supportive of other alternatives, including rank choice voting, which he recommends that the Council consider in addition to adopting the Resolution of Intent.

# Mayor Peters closed the public hearing at 7:00 PM.

<u>Discussion</u>: Much discussion was held amongst the Councilmembers regarding moving forward with the transition to district elections. The Council discussed reaching out to the Latino community, holding forums, and talking to the protected class of voters whose ability to elect preferred candidates is allegedly impaired by the City's at-large election system. The general consensus of the Council was that although they do not prefer to change from at-large to by-district elections in Fort Bragg, they will elect to adopt the resolution of intent in order to minimize the exposure to a large amount of litigation fees.

# 7. CONDUCT OF BUSINESS

City Manager Miller presented the staff report on this agenda item. Public Comment was received from:

- Lynelle Johnson of Mendocino Coast Hospitality Center (MCHC) noted that homeless issues need to be looked at on a countywide basis and then cities can tackle problems on a citywide level. She noted that winter shelters are very important and thanked the Council for recognizing that and for working together to solve problems.
- Jerry Thomas of MCHC urged the Council to endorse the Marbut Report, though he noted that MCHC opposes the concept in the report that Fort Bragg doesn't need an extreme weather shelter. He said MCHC is working with the County to obtain funding.

<u>Discussion</u>: Councilmembers agreed that the effects of homelessness on the community need to be addressed and the Marbut report is a good starting point for many of the problematic issues. The ad hoc committee, the Public Safety Committee, and the Council in general will continue to work with the Police Department, MCHC, and other local stakeholders to try to resolve some of the problems caused by the homeless and transient populations in Fort Bragg.

**7B**. <u>18-260</u>

Receive Report and Consider Adoption of City Council Resolution to Submit a Department of Transportation BUILD Grant for the Skunk Train to Repair Its Tunnel and Track Components

Community Development Director Jones gave the staff report on this item and responded to questions about grant funds, staff time involved, and length of project. Director Jones noted that there was a slight amendment to the Resolution, striking the seventh recital paragraph.

<u>Public Comment</u> was received from:

- Robert Pinoli of the Skunk Train said the City was generous in its willingness to take on the grant submittal and administration. He offered to answer questions from Council on this potential huge project.
- Christopher Hart of Mendocino Railway said he appreciates staff helping with the project, and that they have been quick and responsive. He noted that this is a very competitive grant and if they do not win this one, they will apply for others because they are committed to getting the tunnel and track fixed.
- Gabriel Quinn Maroney said the Skunk Train is a fabulous thing to support and it intersects many regions of the economy.
- George Reinhardt spoke in support of the idea and said it was a good opportunity for Council and staff to educate the community about grants. He stated that replacing toxic railroad ties with safer ones is healthier for the community.

<u>Discussion</u>: After a brief discussion, the Council was in agreement that supporting the Skunk Train was consistent with the City's economic strategy and all Councilmembers were happy to support the resolution as amended.
