Veronica Bazor, student exchange coordinator for the Fort Bragg Otsuchi Cultural Exchange Association, presented a slide show on the group's recent visit to Otsuchi. Fort Bragg High School students Lorelei Hyodo, Clay Anderson, Athena Anderson, Sofia Twomey, Alani Yanez, and Mireya Garcia spoke on the differences and similarities of the Japanese and American cultures and what they learned from the trip. Tim Anderson, FBHS teacher, told stories and gave a gift from the Mayor of Otsuchi to Councilmember Turner. Sharon Davis, co-coordinator of the program, said the children were excellent ambassadors for Fort Bragg and the US and thanked the Council for supporting the program.
