Director Jones presented the report prepared for the Commission.

Discussion:

Commissioners asked clarifying questions regarding the zoning. Director Jones clarified the process of future developments reiterating the Planning Commissions options when approving and or denying future developments.

Further discussion:

Director Jones reminded everyone that open space zone can not be developed, trees can not be cut without a coastal development permit and when a tree is cut the coastal commission requires you plant 2 for every 1 removed tree.

Director Jones reminds the Commission that jobs are of the most intrest to the community. After very thorough and engaging discussion, the Commission gave Director Jones direction and very productive feedback

Planning Commissioners suggest 50ft setback or 200 ft from bluff edge. Planning Commission would recommend a project be exempt from design review and City Council would weigh in on the decision. Commissioners would like the gateway policy applied to Redwood and Cypress for now and they may add areas later. Commissioners spoke in concern with being too prescriptive, without allowing substandard buildings in the industrial zones. Director Jones will draft some materials requirements for industrial zones, add a bike path and landscaping in multifamily zoning
