3A. [19-168](#) Receive Report and Provide a Recommendation to City Council  
Regarding a Proposed Conduct in Public Places Ordinance

City Manager Miller stated the proposed Code Of Conduct in City Facilities and Public Places allows law enforcement to enforce behavior. This would not infringe First Amendment rights, but would allow language and behavior that becomes criminal to be addressed.

3B. [19-169](#) Receive Report and Provide a Recommendation to City Council  
Regarding Proposed Changes to the City's Camping and Sleeping in  
Public Ordinances

City Manager Miller proposed changes to the current ordinance regarding vehicles parked on private property, sleeping in downtown business district and personal property located on private property.

**3C. [19-164](#) Receive Oral Update from Staff on Departmental Activities**

Chief Orsi stated call volume is "off the charts". The total calls for quarter ending 31 March was 236, compared to a usual annual number of 600. There are multiple cases of misuse of 911, but all calls are responded to. The ambulances get most medical calls. People make frivolous calls to 911 for things like locking keys in the car.

Chief Lizarraga provided an update for CGAP Gang Forum on April 25th at Town Hall. Presenters will include Probation, Mendocino County Sheriff, Parole. Gang cases are still being pursued, there have been no more shootings. Officer Welter is now on patrol. Both academy recruits are doing well. Applications are still being accepted for CSO and Police Officer.

City Manager Miller would like to have a meeting with business owners regarding their role in dealing with calls for service to the Police Department. Chief Lizarraga would be available to explain no trespass letters, citizens arrests and aggressive panhandlers
