Board Workshop Regarding the FY 2019-2020 C.V. Starr Community

Center Budget and Provide Direction to Staff

Mendocino Coast Recreation and Park District (MCRPD) District Administrator Dan Keyes gave a brief introduction and overview of the budget, recapping the budget process and how MCRPD uses a team approach. Keyes introduced Moneque Wooden, Business Manager, who read the FY 2019-2020 Budget Report, recapping the operating revenues, operating expenses, capital improvements and the CV Starr Community Center (CVSCC) enterprise fund.

Councilmember Peters entered the chamber at 5:44 PM.

Councilmembers asked questions regarding the pool basin resurfacing project, projected revenue losses due to closure of the pool during resurfacing, and dates of the project. Public Comment: None.

<u>Discussion</u>: The Council discussed outreach programs to schools, families and those who need showers. It was noted that community sponsorships are built into the CVSCC marketing program and passes are offered through the Mendocino Coast Children's Fund each year. It was generally agreed to accept the budget as presented and staff was directed to use the report as submitted for

budget purposes.
